
SENATE BILL NO. 561—COMMITTEE ON FINANCE

SUMMARY—Makes an appropriation to the Keaton Raphael Memorial to provide financial assistance to families who have children with cancer. (BDR S-1441)

AN ACT making an appropriation to the Keaton Raphael Memorial to provide financial assistance to families who have children with cancer; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Keaton Raphael Memorial the sum of \$60,000
- 3 to provide financial assistance to families who have children with
- 4 cancer and to provide related material resources for grants.
- 5 2. Upon acceptance of the money appropriated by subsection 1,
- 6 the Keaton Raphael Memorial shall:
- 7 (a) Prepare and transmit a report to the Interim Finance
- 8 Committee on or before December 15, 2008, that describes each
- 9 expenditure made from the money appropriated by subsection 1
- 10 from the date on which the money was received by the Keaton
- 11 Raphael Memorial through December 1, 2008;
- 12 (b) Prepare and transmit a final report to the Interim Finance
- 13 Committee on or before September 18, 2009, that describes each
- 14 expenditure made from the money appropriated by subsection 1
- 15 from the date on which the money was received by the Keaton
- 16 Raphael Memorial through June 30, 2009; and



1 (c) Upon request of the Legislative Commission, make available
2 to the Legislative Auditor any of the books, accounts, claims,
3 reports, vouchers or other records of information, confidential or
4 otherwise, of the Keaton Raphael Memorial, regardless of their
5 form or location, that the Legislative Auditor deems necessary to
6 conduct an audit of the use of the money appropriated pursuant to
7 subsection 1.

8 **Sec. 2.** Any remaining balance of the appropriation made by
9 section 1 of this act must not be committed for expenditure after
10 June 30, 2009, by the entity to which the appropriation is made or
11 any entity to which money from the appropriation is granted or
12 otherwise transferred in any manner, and any portion of the
13 appropriated money remaining must not be spent for any purpose
14 after September 18, 2009, by either the entity to which the money
15 was appropriated or the entity to which the money was subsequently
16 granted or transferred, and must be reverted to the State General
17 Fund on or before September 18, 2009.

18 **Sec. 3.** The appropriations made by the provisions of this act
19 are not intended to finance ongoing expenditures of state agencies,
20 and the expenditures financed with those appropriations must not be
21 included as base budget expenditures in the proposed budget for the
22 Executive Branch of State Government for the 2009-2011 biennium.

23 **Sec. 4.** This act becomes effective upon passage and approval.
