

SENATE BILL NO. 571—COMMITTEE ON FINANCE

(ON BEHALF OF THE DEPARTMENT OF ADMINISTRATION)

SUMMARY—Makes a contingent appropriation to the Interim Finance Committee for a portion of the costs of constructing a courthouse in White Pine County. (BDR S-1230)

AN ACT making a contingent appropriation to the Interim Finance Committee for a portion of the costs of constructing a courthouse in White Pine County; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Interim Finance Committee for distribution to
- 3 White Pine County the sum of \$6,500,000 for the construction of a
- 4 courthouse.
- 5 2. White Pine County may use the money appropriated by
- 6 subsection 1 only if matching money is provided by White Pine
- 7 County from sources other than the appropriation made by
- 8 subsection 1. White Pine County shall submit proof satisfactory to
- 9 the Interim Finance Committee that the matching money has been
- 10 committed from other sources before the money appropriated may
- 11 be distributed. A portion of the matching money may consist of in-
- 12 kind contributions if approved by the Interim Finance Committee.
- 13 3. A request for distribution of the money appropriated by
- 14 subsection 1 must be submitted to the State Board of Examiners by



1 White Pine County. The State Board of Examiners shall consider the
2 request, may require from White Pine County such additional
3 information as it deems appropriate, and shall, if it finds that the
4 distribution should be made, recommend the amount of the
5 distribution to the Interim Finance Committee for its independent
6 evaluation and action. The Interim Finance Committee is not bound
7 to follow the recommendation of the State Board of Examiners.

8 4. Upon its review of the request for distribution and the
9 recommendation of the State Board of Examiners, the Interim
10 Finance Committee shall, if it finds that a distribution should be
11 made, distribute to White Pine County an amount equal to the actual
12 cost for the work performed, up to the amount appropriated pursuant
13 to subsection 1, contingent upon the receipt of actual billings for
14 that work submitted by White Pine County to the Fiscal Analysis
15 Division of the Legislative Counsel Bureau.

16 **Sec. 2.** Any remaining balance of the appropriation made by
17 section 1 of this act must not be committed for expenditure after
18 June 30, 2011, by the entity to which the appropriation is made or
19 any entity to which money from the appropriation is granted or
20 otherwise transferred in any manner, and any portion of the
21 appropriated money remaining must not be spent for any purpose
22 after September 16, 2011, by either the entity to which the money
23 was appropriated or the entity to which the money was subsequently
24 granted or transferred, and must be reverted to the State General
25 Fund on or before September 16, 2011.

26 **Sec. 3.** This act becomes effective on July 1, 2007.
