SENATE CONCURRENT RESOLUTION—Directing the Legislative Commission to conduct an interim study of background investigations of persons and of records of criminal history.

1 RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE  
2 ASSEMBLY CONCURRING, That the Legislative Commission shall  
3 appoint a subcommittee of six Legislators to conduct an interim  
4 study of background investigations of persons and of records of  
5 criminal history, including, without limitation, the Central  
6 Repository for Nevada Records of Criminal History and the  
7 statewide registry of sex offenders and offenders convicted of a

1 crime against a child established within the Central Repository  
2 pursuant to NRS 179B.200; and be it further

3 RESOLVED, That the subcommittee must consist of:

- 4 1. The Chair of the Senate Standing Committee on Judiciary;
- 5 2. The Chair of the Assembly Standing Committee on  
6 Judiciary;
- 7 3. Two members of the Senate appointed by the Majority  
8 Leader of the Senate; and
- 9 4. Two members of the Assembly appointed by the Speaker of  
10 the Assembly; and be it further

11 RESOLVED, That the subcommittee shall appoint an advisory  
12 committee to assist the subcommittee in carrying out its duties. The  
13 advisory committee must consist of:

- 14 1. The Director of the Department of Corrections or his  
15 designee;
- 16 2. The Director of the Department of Public Safety or his  
17 designee;
- 18 3. The chief officer, other than the Director of the Department  
19 of Public Safety, who administers the Central Repository for  
20 Nevada Records of Criminal History;
- 21 4. The Chief Parole and Probation Officer;
- 22 5. One district attorney from Clark County, one district  
23 attorney from Washoe County and one district attorney from a  
24 county other than Clark County or Washoe County; and
- 25 6. One public defender from Clark County, one public  
26 defender from Washoe County and one public defender from a  
27 county other than Clark County or Washoe County; and be it further

28 RESOLVED, That the subcommittee shall submit its findings, and  
29 recommendations for legislation approved by a majority of the  
30 members of the Senate and a majority of the members of the  
31 Assembly who are appointed to the subcommittee, to the 75th  
32 Session of the Nevada Legislature.
