1 WHEREAS, The State of Nevada lost a civic leader,
2 humanitarian, entrepreneur and, most importantly, a kind,
3 warmhearted man with the sudden and shocking death of Jelindo
4 Angelo Tiberti on May 3, 2006; and

5 WHEREAS, Jelindo Angelo “J. A.” Tiberti was born on April 8,
6 1919, to hard-working Italian immigrants who lived and worked in
7 the coal mining town of Morley, Colorado, until the family moved
8 to Detroit in 1934; and

9 WHEREAS, In addition to running J.A. Tiberti Construction, one
10 of the most successful businesses in the country, J. A. was involved

1 in the growth of the area as a member of the Las Vegas Planning
2 Commission for 25 years and the Board of Directors of the Nevada
3 Power Company for 36 years; and

4 WHEREAS, A man generous with both his time and his money,
5 J. A. Tiberti was active in various professional and philanthropic
6 organizations, including the Las Vegas Rotary Club, the Roman
7 Catholic Diocese of Las Vegas Finance Committee, the Associated
8 General Contractors of America, the Nevada Society of Professional
9 Engineers, and the University of Nevada, Las Vegas, Foundation
10 and Palladium Society; and

11 WHEREAS, A loving father who taught honesty, generosity and
12 ambition by example, J. A. Tiberti is survived by his sons Tito,
13 Renaldo, Mario and Jelindo, daughters Laura and Andra, sister
14 Rosina Peterson, and numerous grandchildren and great-
15 grandchildren; now, therefore, be it

16 RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE
17 ASSEMBLY CONCURRING, That the members of the 74th
18 Legislature offer their sincerest condolences to the family of Jelindo
19 Angelo Tiberti and gratefully acknowledge that the State of Nevada
20 is better for having been the home of this remarkable man for 65
21 years; and be it further

22 RESOLVED, That Jelindo A. Tiberti, the man who loved building
23 things, will be remembered for the legacy he left that includes not
24 only structures throughout Nevada but also a vision of what
25 courageous risk-taking can create, as well as a personal model of
26 humble giving; and be it further
