- 2 professional organization for chefs in North America, with more
- 3 than 19,000 members and 240 chapters nationwide, and its mission
- 4 is “to make a positive difference for culinarians through education,
- 5 apprenticeship and certification, while creating a fraternal bond of
- 6 respect and integrity among culinarians everywhere”; and
- 7 WHEREAS, The American Academy of Chefs is the honor
- 8 society of the American Culinary Foundation which consistently
- 9 inducts chefs who demonstrate the highest standards of

1 professionalism in their field, with the goal of promoting the
2 education of future culinarians by passing on the skills, training and
3 knowledge they possess and by raising money for scholarships; and

4 WHEREAS, The High Sierra Chefs Association is the local

7 northern Nevada and northeastern California and is celebrating its
