SENATE JOINT RESOLUTION—Expressing support for the designation of trails for off-highway vehicles by certain federal agencies.

1        WHEREAS, Approximately 86 percent of Nevada's land is  
2 federally owned, with the Bureau of Land Management managing  
3 68 percent and the United States Forest Service managing 8 percent;  
4 and

5        WHEREAS, Recreation is the fastest growing use of public lands,  
6 and as the population of Nevada and our nation continues to grow,  
7 the demand for recreational use of and access to public lands also  
8 grows; and

9        WHEREAS, Nevada lacks a comprehensive designated route  
10 system for the estimated 400,000 off-highway vehicles in this State  
11 which are part of the lifestyle for many Nevadans; and

12       WHEREAS, The explosion of off-highway vehicle use across the  
13 nation and conflicts with other land uses have often led to  
14 undesirable results, such as serious physical injuries, the spread of  
15 noxious and invasive weeds, environmental damage and litigation or  
16 the closing of federal lands to off-highway vehicles; and

17       WHEREAS, The Bureau of Land Management and the United  
18 States Forest Service recognize the need to improve the  
19 management of off-highway vehicle use, to reduce conflicts and  
20 resource impacts, and to minimize the soil, watershed, wildlife and

1 habitat impacts from off-highway vehicles to protect our public  
2 lands while continuing to provide for a wide variety of recreational  
3 opportunities; now, therefore, be it

4 RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF  
5 NEVADA, JOINTLY, That the Nevada Legislature hereby supports  
6 the actions and policies of the Bureau of Land Management and the  
7 United States Forest Service which designate specific roads, trails  
8 and limited-use areas for use by off-highway vehicles and hereby  
9 urges the Bureau of Land Management and the United States Forest  
10 Service to carry out those actions and policies in cooperation with  
11 other groups, including local law enforcement, hunting, hiking,  
12 biking, ranching and conservation groups and others who work on  
13 issues involving Nevada's backcountry; and be it further

14 Resolved, That the Nevada Legislature urges the Bureau of  
15 Land Management and the United States Forest Service to require  
16 that off-highway vehicles stay on existing roads and trails and not  
17 pioneer unauthorized roads and trails; and be it further

18 RESOLVED, That the Bureau of Land Management and the  
19 United States Forest Service are encouraged to enter into  
20 interagency agreements with federal, state and local law  
21 enforcement agencies to use resources efficiently and to ensure  
22 sufficient enforcement of policies and regulations; and be it further

23 RESOLVED, That the Secretary of the Senate prepare and  
24 transmit a copy of this resolution to the Secretaries of Agriculture  
25 and the Interior, the Chief of the United States Forest Service, the  
26 Director of the Bureau of Land Management and each member of  
27 the Nevada Congressional Delegation; and be it further

28 RESOLVED, That this resolution becomes effective upon  
29 passage.
