## INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Commerce and Labor:

Assembly Bill No. 88—AN ACT relating to collection agencies; requiring a collection agency to submit a written notice to a debtor within a certain period after the initial communication with the debtor; requiring a collection agency to cease collection of a debt under certain circumstances; prohibiting a collection agency from applying a payment to a debt or portion of a debt that is disputed by the debtor under certain circumstances; revising the circumstances under which a collection agency may commence a legal action against a debtor; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Oceguera moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblymen Parnell, Bobzien, Hogan, Kirkpatrick, Pierce, and Smith: Assembly Bill No. 89—AN ACT relating to public employees; including certain park rangers and employees of the Division of State Parks of the State Department of Conservation and Natural Resources in the definition of "police officer" for various purposes relating to industrial injuries, occupational diseases and programs for public employees; making an appropriation; and providing other matters properly relating thereto.

Assemblywoman Parnell moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 90—AN ACT relating to crimes; prohibiting a person from engaging in certain acts to cause the results of a test for genetic identification which is given to determine paternity to be inaccurate; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Oceguera moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 91—AN ACT relating to explosives; providing a list of chemicals designated as explosives; enacting provisions relating to the labeling of containers used for storing explosives; establishing requirements concerning the making of mandatory reports to law enforcement agencies regarding the distribution of explosives under certain circumstances; revising the provisions relating to records regarding transactions and inventories of explosives; revising the provisions relating to the inspection of facilities used for explosives; providing a penalty; and providing other matters properly relating thereto.

Assemblywoman Gerhardt moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 92—AN ACT relating to criminal procedure; expanding the crimes for which a convicted person is required to submit a biological specimen to be used for genetic marker analysis; and providing other matters properly relating thereto.

Assemblyman Anderson moved that the bill be referred to the Committee on Judiciary.

Assemblywoman Leslie moved that the bill be referred to the Committee on Government Affairs.
