# MOTIONS, RESOLUTIONS AND NOTICES

By Assemblymen Ohrenschall, Horne, Buckley, Carpenter, Gerhardt, Hogan, Mabey, Manendo, Munford, Pierce, Segerblom, Settelmeyer, and Womack:

Assembly Joint Resolution No. 2—Proposing to amend the Nevada Constitution to prohibit the taking of private property for any private use.

RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY, That Section 8 of Article 1 of the Nevada Constitution be amended to read as follows:

- Sec. 8. 1. No person shall be tried for a capital or other infamous crime (except in cases of impeachment, and in cases of the militia when in actual service and the land and naval forces in time of war, or which this State may keep, with the consent of Congress, in time of peace, and in cases of petit larceny, under the regulation of the Legislature) except on presentment or indictment of the grand jury, or upon information duly filed by a district attorney, or Attorney General of the State, and in any trial, in any court whatever, the party accused shall be allowed to appear and defend in person, and with counsel, as in civil actions. No person shall be subject to be twice put in jeopardy for the same offense; nor shall he be compelled, in any criminal case, to be a witness against himself.
- 2. The Legislature shall provide by law for the rights of victims of crime, personally or through a representative, to be:

- (a) Informed, upon written request, of the status or disposition of a criminal proceeding at any stage of the proceeding;
  - (b) Present at all public hearings involving the critical stages of a criminal proceeding; and
  - (c) Heard at all proceedings for the sentencing or release of a convicted person after trial.
- 3. Except as otherwise provided in subsection 4, no person may maintain an action against the State or any public officer or employee for damages or injunctive, declaratory or other legal or equitable relief on behalf of a victim of a crime as a result of a violation of any statute enacted by the Legislature pursuant to subsection 2. No such violation authorizes setting aside a conviction or sentence or continuing or postponing a criminal proceeding.
- 4. A person may maintain an action to compel a public officer or employee to carry out any duty required by the Legislature pursuant to subsection 2.
  - 5. No person shall be deprived of life, liberty, or property, without due process of law.
- 6. Private property shall not be taken for public use without just compensation having been first made, or secured, except in cases of war, riot, fire, or great public peril, in which case compensation shall be afterward made. *Private property shall not be taken for any private use*.

Assemblyman Ohrenschall moved that the resolution be referred to the Committee on Elections, Procedures, Ethics, and Constitutional Amendments.

Assembly Concurrent Resolution No. 4—Designating February 19, 2007, as Homeless Awareness Day in Nevada.

WHEREAS, On January 10, 2007, the National Alliance to End Homelessness issued a report ranking Nevada as having the second highest percentage per capita of homeless persons, with more than double the national average; and

WHEREAS, According to the report, an estimated 744,313 people experienced homelessness nationally, including 16,402 people in Nevada; and

WHEREAS, These figures do not take into account those persons who are on the edge of homelessness, living paycheck to paycheck, one step away from becoming homeless; and

WHEREAS, There are many reasons for homelessness, including, without limitation, unemployment, low wages, lack of affordable housing, lack of health insurance, domestic violence, and substance abuse and mental health issues; and

WHEREAS, One of the fastest growing segments of the homeless population in this country consists of families with children; and

WHEREAS, Homelessness disrupts every aspect of family life, adversely affecting physical and mental health, interfering with education and childhood development, and often resulting in the separation of family members; and

WHEREAS, Strategies for fighting homelessness that have shown positive results include the appropriation of money to provide assistance to homeless persons and the establishment of programs that focus on permanent housing and services to help the chronically homeless lead more stable lives; and

WHEREAS, To raise awareness of the issues faced by homeless persons in Nevada, including the need for transitional housing and mental health assistance, some Nevada

Legislators and various other concerned citizens slept in a "Tent City" outside of the Legislative Building on February 18, 2007; and

WHEREAS, The members of the Nevada Legislature recognize the outstanding efforts of the numerous state and local governmental agencies and various nonprofit entities dedicated to fighting homelessness in the State of Nevada; now, therefore, be it

RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE SENATE CONCURRING, That February 19, 2007, is hereby designated as Homeless Awareness Day in Nevada; and be it further

RESOLVED, That the members of the 74th Session of the Nevada Legislature hereby express their commitment to creating a greater public awareness of the problem of homelessness in Nevada and resolve to continue to work cooperatively to solve this problem; and be it further

RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy of this resolution to Michael Dayton, Chief of Staff to Governor Jim Gibbons.

Assemblywoman Leslie moved the adoption of the resolution.

Remarks by Assemblywoman Leslie.

Assemblywoman Leslie requested that her remarks be entered in the Journal.

### ASSEMBLYWOMAN LESLIE:

Everyone knows that homelessness is a huge problem in our country and in our state. The Urban Institute estimates that between 2.3 million and 3.5 million people per year in the United States experience homelessness. Of those, 23 percent are chronically homeless, which means that they are homeless for long periods of time and often have a disability of mental illness or substance abuse or a physical disability. The other 77 percent of those who are homeless at any one time are considered nonchronic. Approximately 59 percent of the homeless population counted in January 2005 were individuals, while 41 percent were people in families with children.

In Nevada, we have the dubious distinction of having the highest percentage of homeless individuals of any state—6.68 percent of every 100,000 of our population in Nevada is homeless. The only area that exceeds Nevada is Washington, D.C.

A statewide survey conducted in 2005 revealed that over 19,000 people in Nevada are homeless. About 13,000 of those live in Clark County, about 2,500 of those live in the Reno-Sparks area, and 3,500 are spread throughout the rest of the state.

The most common factors of homelessness in our state include domestic violence; the inability to find an affordable house or apartment; unemployment; a sudden illness in the family; or an unforeseen medical expense, car repair, or anything out of the ordinary.

Most disturbing of all is families with children are among the fastest growing segment of the homeless population in our state. Housing, an adequate income, health care, and mental health services and/or drug treatment are some of the answers to this problem of homelessness.

Under Order of Business 15, later, we will have some additional information for you, but as far as the members on this ACR, I hope you will join me in voting "aye."

Resolution adopted.

Assemblywoman Leslie moved that all rules be suspended and that Assembly Concurrent Resolution No. 4 be immediately transmitted to the Senate.

### REMARKS FROM THE FLOOR

Assemblyman Oceguera requested that the following remarks be entered in the Journal.

## ASSEMBLYWOMAN LESLIE:

Thank you, Madam Speaker. Many of you knew of or perhaps even saw when you came to work today a lot of the tents and soggy boxes outside between our building and the Capitol. I am really pleased to report that we had over 100 people spend the night. At one point yesterday afternoon, as part of our "Tent City," we had more than 250 people here, many of them from Las Vegas. Those of you who have served here for a long time know how rare it is and how wonderful it is to see your constituents make the long trip. Many of them took a very long bus ride yesterday to get here. They will be taking a long bus ride to get back home. So, first of all, I would like to thank all our constituents who participated in the Tent City event yesterday and last night, which was cold and snowy here in northern Nevada. Please stand up and be recognized.

Thank you. Madam Speaker, if I may continue. Some of them look a little ragged, but some of them look a lot better than they did at 11 p.m. when the snow and sleet were coming down. I don not know how you cleaned up, but you did a good job. I especially want to recognize the Assembly members who braved the cold and were there, crawling out at various times this morning from their boxes and tents. The Assembly members from Districts 3, 34, 37, and 41—my Las Vegas colleagues—thank you very much; also, my colleague from Reno in District 24. We even had a Senator there from District 4. We really appreciated that.

There were quite a few other Assembly members who stopped by, like the Majority Leader. I am trying to adhere to protocol but I will just give up on that. Ms. Womack was there, Mrs. Smith was there, Ms. Parnell was there. Lots of Assembly members came by, even if they did not spend the night.

I think that for those of us who did spend the night—and I will speak for myself—it really was a wonderful experience for us. I have never had the opportunity of smelling wet cardboard all night. It was different. We chose that night, as we are reminded repeatedly. We chose to be homeless last night. Most homeless people in our state do not get to choose to be homeless. I think for many of us, and certainly for me, spending the night outside helped to reflect on what it is like for the residents of our state who do not have a home to go to, and who have to sleep like that every day, regardless of whether the weather is balmy or it is snowy or it is cold—and probably without the kind of sleeping bags many of us had last night. It was a mind-opening experience. I think it really brought home the need for our state to do better so that two years from now, we are not standing here saying we have the worst record of any state in the nation. Thank you very much to my colleagues for spending the night. Maybe two years from now some of the rest of you will want to take that action yourselves.

Madam Speaker requested the privilege of the Chair for the purpose of making the following remarks:

I would just like to add my thanks to all of you who made the journey here to support public awareness for the homeless. I cannot imagine anything worse than being alienated from your family and sleeping on the street. I think this is probably one of the toughest things to advocate for. I see so many of you that I have worked with over the years. You advocate day in, day out, working so well in your communities across the state, trying for our society to not turn its back on our brothers and sisters. As we give our recognition to this important resolution, I also want to recognize each one of you for everything that you do to make our state a better place. Thank you.
