INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 208—AN ACT relating to transportation; requiring employees of the Transportation Services Authority and the Taxicab Authority to wear identifying uniforms and use marked vehicles when exercising enforcement powers in certain circumstances; requiring such employees to have probable cause when stopping or detaining a vehicle while exercising enforcement powers; making such employees who are also peace officers eligible for certain retirement benefits; requiring the Transportation Services Authority and the Taxicab Authority to adopt policies and procedures governing their organizations and operations; requiring notice to be provided before the examination of certain records; requiring the Transportation Services Authority to bring a civil action to recover certain civil penalties instead of imposing certain administrative fines; and providing other matters properly relating thereto.

Assemblyman Goedhart moved that the bill be referred to the Committee on Transportation.

Assembly Bill No. 209—AN ACT relating to the taxation of property; revising the provisions governing certain exemptions from taxes and appeals by taxpayers; revising the provisions governing the collection of taxes following certain fluctuations in taxable value; providing limitations upon certain requests for the waiver of interest and penalties imposed for the late payment of taxes; repealing the prospective expiration of certain provisions for the funding of accounts for the acquisition and improvement of technology in the offices of county assessors; and providing other matters properly relating thereto.

Assemblywoman McClain moved that the bill be referred to the Committee on Taxation.

Assembly Bill No. 210—AN ACT relating to property taxes; revising provisions governing the eligibility of certain veterans for an exemption from taxation and certain requirements for the assessment of common-interest communities; increasing the maximum amount to which certain senior citizens are entitled as a refund of part of the taxes on their homes; repealing the prospective expiration of an exemption from the taxation of the property of certain apprenticeship programs; and providing other matters properly relating thereto.

Assembly Bill No. 211—AN ACT relating to education; authorizing the board of trustees of certain school districts to adopt a program of school choice; providing for the reimbursement of certain transportation costs incurred by a school district that provides such a program; and providing other matters properly relating thereto.

Assembly Bill No. 212—AN ACT relating to education; requiring the boards of trustees of school districts to prescribe a policy for the development of 4-year academic plans for pupils enrolled in high school; requiring the principals of certain larger high schools to provide for a program of a ninth grade school within a school; requiring the State Board of Education to prescribe a uniform grading scale for high schools; requiring each school district to adopt a policy setting forth the duties of school counselors; expanding the age for compulsory school attendance from 17 years to 18 years; and providing other matters properly relating thereto.

Assemblywoman Parnell moved that the bill be referred to the Committee on Education.
