Assembly Concurrent Resolution No. 13—Honoring the accomplishments of United States Air Force Major Nicole Malachowski.

WHEREAS, Every year as millions of spectators experience the thrill of watching the precision aerial acrobatics of the United States Air Force Air Demonstration Squadron, known as the Thunderbirds, the skill and teamwork of the pilots who provide the excitement are readily recognized and appreciated; and

WHEREAS, The Thunderbirds, who have proudly represented the men and women wearing Air Force blue since 1953, turned a new page in history in March 2006, when Nicole Malachowski made her public debut as the team's first female pilot; and

WHEREAS, After being mesmerized by an air show as a young girl at 5 years of age, Nicole decided that she would one day be a fighter pilot, and despite being told by some that "girls can't be fighter pilots" and growing up with the reality that indeed women were, at that time, not allowed to fly fighter planes, Nicole never wavered from her goal; and

WHEREAS, While her peers were focused on getting their driver's licenses, Nicole was taking flight lessons at the North Las Vegas Airport and made her first solo flight there, and after graduating from Western High School in Las Vegas, she was chosen to enter the United States Air Force Academy and was commissioned in 1996; and

WHEREAS, Upon the completion of a lengthy process of letter submission, interviews and a flight test at Nellis Air Force Base, then Captain Malachowski was one of three pilots selected to become members of the Thunderbirds; and

WHEREAS, Major Malachowski, call sign "Fifi," has, since her selection, attained a summit in fulfilling her lifetime dream as she expertly guides her F-16 Fighting Falcon in the right-wing position of the famous Thunderbird diamond formation; and

WHEREAS, In addition to the time spent on training and performing as a pilot, Major Malachowski dedicates many hours to community outreach and often speaks to children, emphasizing teamwork and encouraging them to pursue something they are passionate about and to pursue excellence in that endeavor; and

WHEREAS, Nicole Malachowski is the epitome of what she teaches and has not only become a role model for all young women but also an inspiration for everyone who hears her remarkable story; now, therefore, be it

RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE SENATE CONCURRING, That the members of the 74th Session of the Nevada Legislature do hereby honor Major Nicole Malachowski for her extraordinary accomplishments as a pilot and as an exemplary representative of our country and the United States Air Force; and be it further

RESOLVED, That the members of this Legislature and the residents of the State of Nevada praise Nicole Malachowski for her dedication to her country and to her dreams and extol her as a role model for all young Americans; and be it further

RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy of this resolution to Major Nicole Malachowski.

Remarks by Assemblyman Horne and Madam Speaker.

Assemblyman Oceguera requested that the following remarks be entered in the Journal.

ASSEMBLYMAN HORNE:

Thank you for the opportunity to honor Major Malachowski. Let me take a moment to walk this body through this remarkable and overachieving woman's accomplishments.

At the age of 12, she had an assignment in school to give an oral report on what she wanted to be in her life. Confidently, Nicole rose and proclaimed that she would be an Air Force fighter pilot. This was at a time when women were not permitted to fly fighter aircraft in the military.

After some ridicule from her classmates and even her teacher—this would fall under the title "You're not the boss of me"—she said, "Nobody can tell me what I can or cannot be when I grow up."

In 1989, Nicole joined the Civil Air Patrol and enrolled in her sophomore year at Western High School in Las Vegas. At Western, she joined the Air Force Junior ROTC program and then rose to the position of Corp Commander, the rank of Cadet Lieutenant Colonel. Nicole also achieved the national honor of the United States Air Force Junior ROTC Top Cadet and was promoted to Cadet Colonel, the only cadet in the nation to receive that honor.

Recognizing Nicole's obvious talents, she received full military scholarships to the Air Force Academy and Annapolis—I think she made the right choice in choosing the Air Force Academy. At the Academy, she became the first female to become commander of the Cadet Soaring Program.

Nicole graduated from the Air Force Academy in 1996 and in 1997 received her wings, which were proudly pinned on her by her father, Mr. Ellingwood, who is sitting here with us today. Her father was probably so proud because he was watching his daughter continue a tradition set by her grandfathers James Gist and Robert Ellingwood, both veterans of World War II and the Korean War.

Because Major Malachowski graduated near the top of her flight class, she was able to choose the only allotment slot to the class for the F-15E Strike Eagle. Major Malachowski has since logged over 1,900 flight hours; more than 188 of those are combat hours. Some of those combat hours were logged while leading a two-ship air cover over Baghdad on their historic election day.

Major Malachowski continued to make history when on June 16, 2005—her father's birthday, by the way—she was named to the Air Force Thunderbirds Performance Team, the first woman to do so.

Please join me in honoring Major Nicole Malachowski for her remarkable military career thus far.

Madam Speaker requested the privilege of the Chair for the purpose of making the following remarks:

I would like to join the tribute given by Assemblyman Horne and congratulate you for your daughter's accomplishments. We know what a great role you must have played, and we hope that one day, no young woman will be told that she cannot do something because of her gender. As the first woman Speaker in the history of the state of Nevada, I want to give my special congratulations to your daughter.

I would like to say that when I first read about Major Malachowski making the Air Force Thurderbird's Team, I was thrilled, not just because I, also, attended Western High School and not because I, also, was in the Air Force Junior ROTC department there. I was thrilled because she had done something which was remarkable in and of itself, whether you are a man or a

woman. She made this elite team. She did it as a woman. She set a goal to become a fighter pilot at a time when it was not thought of. It just wasn't going to happen for women. She was told as much. I have been there. When I first said I wanted to be a fighter pilot, I was told by a teacher I had to go to college, as if that wasn't possible.

Nicole didn't let anything stand in her way. I thought back to the comments of people saying Nevadans need to step up. They need to be good Americans. Nevadans have been stepping up since we were brought into the union.

Nicole didn't let anyone tell her no. She didn't let her gender stand in the way. With the guidance of her wonderful parents, she achieved her dream. I hope that many other boys and girls who have high aspirations don't let anyone else try to hold them down. I hope they reach for those stars, as Major Malachowski did. She honors Nevadans and she honors boys and girls who have lofty dreams. That is why I was so proud to bring this resolution, and I want to thank her parents for making the trip up. It's too bad the Major couldn't be here, but her duties called her elsewhere. I thank this body for recognizing her, Madam Speaker.
