## INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Goedhart, Hardy, Mabey, Beers, Cobb, Marvel, Settelmeyer, and Stewart:

Assembly Bill No. 370—AN ACT relating to crimes; prohibiting the attempted use of a credit card or debit card of another person without the

cardholder's consent; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Goedhart moved that the bill be referred to the Committee on Judiciary.
