AN ACT making a supplemental appropriation to the Department of Health and Human Services for expenses relating to foster care; and providing other matters properly relating thereto.

# THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. There is hereby appropriated from the State General Fund to the Department of Health and Human Services for Clark County Integration the sum of [\$3,696,791] \$3,320,695 for an unanticipated shortfall in purchased placement costs and for 14 full-time equivalent positions needed for the increased foster care caseload. This appropriation is supplemental to that made by section 20 of chapter 434, Statutes of Nevada 2005, at page 1940.

Sec. 2. This act becomes effective upon passage and approval.

Amendment No. 650.

SUMMARY—Provides for audits by Legislative Auditor of entities which are not state agencies but which receive appropriations of [public] state money. (BDR 17-91)

"AN ACT relating to legislative audits; providing for audits by the Legislative Auditor of entities which are not state agencies but which receive appropriations of [public] state money; requiring such an entity, as a condition of the acceptance of an appropriation, to agree to make available to the Legislative Auditor all records of information that he determines to be necessary to conduct such an audit; and providing other matters properly relating thereto."

Legislative Counsel's Digest:

This act requires the Legislative Auditor, as directed by the Legislative Commission, to audit an entity which is not an "agency of this State" as defined in NRS 218.737 but which receives an appropriation of [public] state money. The audit must examine the use of the [public] state money by the entity. This act also requires such an entity, as a condition of the acceptance of an appropriation of [public] state money, to agree to make available to the Legislative Auditor all records of information that the Legislative Auditor determines to be necessary to conduct the audit. Such an audit will be subject to the terms set forth in NRS 218.737 to 218.893, inclusive, governing audits conducted by the Legislative Auditor.

# THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 218 of NRS is hereby amended by adding thereto a new section to read as follows:

- 1. The Legislative Auditor, as directed by the Legislative Commission pursuant to NRS 218.850, shall conduct a special audit of an entity which is not an agency of this State but which receives an appropriation of [public] state money during any fiscal year. Such an audit must, without limitation, examine the use of the [public] state money received by the entity.
- 2. As a condition of the acceptance of any appropriation of [public] state money, an entity which is not an agency of this State must agree to make available to the Legislative Auditor all books, accounts, claims, reports, vouchers or other records of information, confidential or otherwise and irrespective of their form or location, that the Legislative Auditor determines to be necessary to conduct an audit pursuant to this section.
  - Sec. 2. NRS 218.737 is hereby amended to read as follows:

- 218.737 As used in NRS 218.737 to 218.893, inclusive, *and section 1 of this act*, "agency of the State" includes all offices, departments, boards, commissions and institutions of the State and the judicial department of the State, but does not include the Legislative Branch of Government.
  - Sec. 3. NRS 218.850 is hereby amended to read as follows:
- 218.850 1. Each of the audits provided for in this chapter must be made and concluded as directed by the Legislative Commission and in accordance with the terms of NRS 218.737 to 218.893, inclusive [...], and section 1 of this act.
- 2. The Legislative Commission shall direct the Legislative Auditor to make any special audit or investigation that in its judgment is proper and necessary to carry out the purpose of this chapter or to assist the Legislature in the proper discharge of its duties.
  - Sec. 4. This act becomes effective on July 1, 2007.

## ASSEMBLYWOMAN KIRKPATRICK:

Senate Bill 567 does a few things today. Currently, S.B. 567 suspends all actions of the state agencies relating to lead sales tax exemptions and property tax abatements authorized in A.B. 3 of the 2005 Special Session. It also ensures our commitment to green building in the Nevada Legislature.

Last session, 63 of us voted that we supported green building, and we want to ensure our commitment to that program. Also, it allows us the opportunity to evaluate the regulations that are currently in place or not. We need to verify that the intent of the Legislature was met.

Assembly Bill 3, section 7, allowed our regulatory bodies to set regulations in place to incentivize this program. At this time, we just need to stand back and make sure that all of those regulations have been put in place. We have several applications, and it is a very important project.

Nevada is currently the leader in this, so we want to make sure that we are on the same page. We also need to ensure that, according to the *Nevada Constitution*, anytime we give an exemption we first have to make sure that our state is whole, whether it is providing for our schools, our seniors, or our government services. That is also something that will be considered.

Senate Bill 567 also talks about the 63 legislators, Assemblymen and Senators, wanting to work together to evaluate the situation to make sure that we address green building within our state. We have made a commitment to suspend the rules only temporarily.

This is kind of an important issue to all of us in here. I think that at the end of the day we have made the commitment, in the next 30 days, to look at this, to address it, and to make sure the intent of what we do in this body is put into the regulations so that we can address the fiscal impact that may happen within our state. With that, I urge your support on S.B. 567.

#### ASSEMBLYWOMAN SMITH:

Thank you, Madam Speaker. I, too, rise in support of Senate Bill 567. I think this Legislature has adequately demonstrated, in the last session and in this session that we care about green buildings. We care about buildings having programs that support energy conservation and renewable energy. This bill just gives us an opportunity to take a breath and look at all the actions that have taken place and make sure the regulations are sound and equitable and fair and that we are being fiscally prudent as we move forward. We have a huge responsibility to this state to make sure we are taking care of the students in our schools and the citizens in our state who we serve. I think just taking this time to make sure we are moving forward in a prudent fashion is so important to us. I hope that my colleagues will support this bill and allow us to examine what we have done, and we can do to move forward in a prudent fashion. Thank you, Madam Speaker.

#### ASSEMBLYMAN MABEY:

Thank you, Madam Speaker. I rise in support of Senate Bill 567. I support the desires of this body to do what is best for all of Nevada. I feel this bill will do that. I support the desire to encourage energy efficient buildings; however, a proper balance is necessary. My hope is that no one here knew what the unattended consequences or the current ramifications of Assembly Bill 3 of the 22nd Special Session would be. Thank you.
