Senate Concurrent Resolution No. 5—Memorializing native Nevadan and longtime patriarch of the Comstock, Donald G. McBride.

WHEREAS, On April 20, 2006, the residents of Virginia City said good-bye to Don McBride, owner of the Bucket of Blood Saloon and avid Comstock preservationist; and

WHEREAS, Donald Giles McBride was born on February 1, 1928, in Winnemucca to Versal and Marie McBride; and

WHEREAS, When Don was 3 years old, the McBride family moved to Virginia City which became their home and purchased the property now known as the Bucket of Blood Saloon which became their livelihood; and

WHEREAS, Don had the utterly unique experience of growing up in one of the greatest authentic old mining towns, attending the Fourth Ward School and graduating from Virginia City High School in 1946; and

WHEREAS, Virginia City was the place of choice for Don and his wife Jeannie to raise their sons Steve, Marshall and Don while carrying on the legacy and business of the Bucket of Blood; and

WHEREAS, With dedication, devotion and enthusiasm, Don worked tirelessly to promote Virginia City and the Comstock by organizing events like Bonanza Days, the Camel Races and the Mountain Oyster Fry; and

WHEREAS, A penchant for public service being Don's forte and joy, he served as President of the Virginia City Chamber of Commerce, President of the Businessmen's Association, a Commissioner on the Comstock Historic District Commission, a board member of Piper's Opera House, and a member of the Fraternal Order of Eagles Aerie 523 and of the Julia Bulette Chapter of E. Clampus Vitus; and

WHEREAS, Don loved to hold forth at the Bucket of Blood, with a bowl of popcorn always ready for munching, sharing the history of Virginia City and Nevada with visitors from near and far; now, therefore, be it

RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE ASSEMBLY CONCURRING, That the members of the 74th Session of the Nevada Legislature do hereby extend their heartfelt condolences to the family of Don McBride, a man who was instrumental in turning Virginia City from a dying mining town to one of Nevada's premier tourist attractions; and be it further

RESOLVED, That Don McBride will be remembered by all who knew him as a wholehearted believer in the Comstock, its residents and its future, and as a man deeply proud to call Virginia City his home; and be it further

RESOLVED, That the Secretary of the Senate prepare and transmit a copy of this resolution to Don's sons Steve, Marshall and Don.

Senator Amodei moved the adoption of the resolution.

Remarks by Senator Amodei.

Senator Amodei requested that his remarks be entered in the Journal.

Thank you, Mr. President. This resolution honors someone who was the fabric of his community and his region. Don McBride's accomplishments were many and community minded. Whenever I was in Virginia City, before my time in public life and since, I would see Don on patrol. He was the unofficial Sheriff's patrol around town. A person could not sneak into town without Don knowing that person was there. I ask your support and vote for Senate Concurrent Resolution No. 5 honoring Don McBride.

Senator Heck moved that the bill be referred to the Committee on Transportation and Homeland Security.

Senate Bill No. 107—AN ACT relating to transportation; abolishing the Transportation Services Authority and transferring the duties and responsibilities; authorizing certain local governmental entities to assume regulatory authority over taxicabs and limousines based within the jurisdiction of the governmental entity; establishing the Consumer Affairs Division Regulatory Fund and the Nevada Highway Patrol Regulatory Fund; eliminating the Transportation Services Authority Regulatory Fund; and providing other matters properly relating thereto.

Senate Bill No. 108—AN ACT relating to the state budget process; providing for the use of zero-based budgeting in preparing the proposed budgets of a certain portion of the Executive Department of State Government each biennium; requiring the Chief of the Budget Division of the Department of Administration to adopt certain regulations to carry out zero-based budgeting; and providing other matters properly relating thereto.

Senate Bill No. 109—AN ACT relating to education; eliminating the requirement that certain applicants for the millennium scholarship maintain a certain high school grade point average for receipt of the scholarship; requiring certain applicants to receive at least the statewide average score on certain college entrance examinations; and providing other matters properly relating thereto.

Senator Beers moved that the bill be referred to the Committee on Human Resources and Education.

Senate Bill No. 112—AN ACT relating to controlled substances; requiring entities that sell certain products that are precursors to methamphetamine to place such products in an area to which the public does not have direct access, to limit the quantity of such products sold or transferred to the same person during any 24-hour period, to maintain a list of sales of such products and to ensure that certain information is entered in that list; prohibiting a person from acquiring more than a certain amount of certain products that are precursors to methamphetamine; providing penalties; and providing other matters properly relating thereto.

MOTIONS, RESOLUTIONS AND NOTICES

Assembly Concurrent Resolution No. 4—Designating February 19, 2007, as Homeless Awareness Day in Nevada.

WHEREAS, On January 10, 2007, the National Alliance to End Homelessness issued a report ranking Nevada as having the second highest percentage per capita of homeless persons, with more than double the national average; and

WHEREAS, According to the report, an estimated 744,313 people experienced homelessness nationally, including 16,402 people in Nevada; and

WHEREAS, These figures do not take into account those persons who are on the edge of homelessness, living paycheck to paycheck, one step away from becoming homeless; and

WHEREAS, There are many reasons for homelessness, including, without limitation, unemployment, low wages, lack of affordable housing, lack of health insurance, domestic violence, and substance abuse and mental health issues; and

WHEREAS, One of the fastest growing segments of the homeless population in this country consists of families with children; and

WHEREAS, Homelessness disrupts every aspect of family life, adversely affecting physical and mental health, interfering with education and childhood development, and often resulting in the separation of family members; and

WHEREAS, Strategies for fighting homelessness that have shown positive results include the appropriation of money to provide assistance to homeless persons and the establishment of programs that focus on permanent housing and services to help the chronically homeless lead more stable lives; and

WHEREAS, To raise awareness of the issues faced by homeless persons in Nevada, including the need for transitional housing and mental health assistance, some Nevada Legislators and various other concerned citizens slept in a "Tent City" outside of the Legislative Building on February 18, 2007; and

WHEREAS, The members of the Nevada Legislature recognize the outstanding efforts of the numerous state and local governmental agencies and various nonprofit entities dedicated to fighting homelessness in the State of Nevada; now, therefore, be it

RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE SENATE CONCURRING, That February 19, 2007, is hereby designated as Homeless Awareness Day in Nevada; and be it further

RESOLVED, That the members of the 74th Session of the Nevada Legislature hereby express their commitment to creating a greater public awareness of the problem of homelessness in Nevada and resolve to continue to work cooperatively to solve this problem; and be it further

RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy of this resolution to Michael Dayton, Chief of Staff to Governor Jim Gibbons.

Senator Titus moved the adoption of the resolution.

Remarks by Senators Titus and Horsford.

Senator Titus requested that the following remarks be entered in the Journal.

SENATOR TITUS:

With exception of those who spent the night on the front lawn in the cold and have joined us this morning from the tent city, the rest of us came to the Legislature after having spent the night

in a warm bed and a warm home. No one here is homeless, and that is why we need to take a moment to recognize the problems of homelessness and how it affects our State.

Certainly, the statistics are staggering. There are between 2.3 and 3.5 million people per year who experience homelessness in this wonderful, wealthy Country. Of those, 44 percent are always unsheltered because they do not have a traditional home. It is stated that 23 percent of homeless people have a physical disability, mental illness or suffer from substance abuse. Unfortunately, Nevada is at the top of the list in this Country with the second highest percentage of homeless individuals per 100,000 of the population. Only our Nation's capital, Washington D.C. is ahead of us. Over 19,000 people in Nevada are homeless. There are approximately 13,000 homeless in the Las Vegas area, 2,500 in the Reno Sparks area and 3,500 throughout the rest of the State. Even more striking, especially in the context of having heard this information this morning in the Committee on Finance, so many of these homeless are children. Fifteen percent of Nevada's children live in poverty. This is unacceptable. We need to address this issue. We are appreciative of this resolution and legislation being introduced in the Assembly today. I urge your support of Assembly Concurrent Resolution No. 4.

SENATOR HORSFORD:

Thank you, Mr. President. I, too, rise in support of Assembly Concurrent Resolution No. 4.

I wish to commend the individuals who braved the cold last night. When I was first asked to participate, I did not think of the consequences of sleeping outside in the cold. As many of you know, the temperature outside last night was freezing. It rained and snowed. As I started to learn more about the issues of homelessness, I realized I had not considered myself homeless as a child. Children are adversely affected by homelessness. There are people who live paycheck to paycheck, and many of the children in these families are living in homeless conditions because of this. These children do not recognize they are homeless. In the middle of last night I was struck by the thought that as the raindrops were falling on the tent, a luxury many homeless do not have, it was so cold I could not imagine a child living in such conditions. I applaud the organizers of the event, those who are bringing awareness to homelessness, this legislative body and the Legislature itself, for standing ready and able to secure Nevada's future, that of our children and those who live under these conditions. I thank this body for its support last session and, hopefully, again this Session.
