Professor Rothman was a distinguished professor in the History Department at UNLV. He is the author of 17 books including *Devil's Bargains: Tourism in theTtwentieth Century American West* (1998); Saving the Planet: The American Response to the Environment in the Twentieth Century (2000): The Grit Beneath the Glitter: Tales From the Real Las Vegas (2002): Neon Metropolis: How Las Vegas Started the Twenty-First Century (2002): and The Tourism of Culture, the Culture of Tourism (2003).

Hal was a columnist for the *Las Vegas Sun* and a well-known and respected national pundit on Las Vegas life and culture. An excellent article by Joe Schoenmann appeared in the *Las Vegas Sun* just two weeks ago which pays homage to Hal and the strength and optimism with which he faced his final days.

He is survived by his wife Lauralee, daughter Talia and son Brent as well as his parents and two sisters. His legacy will live on in the minds and hearts of his many readers, students, colleagues and admirers.
