Senate Concurrent Resolution No. 9—Urging the public schools and school districts in this State to preserve and strive to expand the amount of time allocated for physical education, physical activity and recess.

WHEREAS, Nationally, approximately 16 percent of children between the ages of 6 and 19 years old are overweight, leading to an increased risk for heart disease, high cholesterol, high blood pressure and type 2 diabetes, and a 70 percent chance of becoming overweight or obese as adults; and

WHEREAS, The Surgeon General of the United States has stressed the importance of quality physical education for at least 60 minutes daily for all grade levels; and

WHEREAS, Recent findings indicate that both proper nutrition and regular, vigorous physical activity improve academic achievement and that quality physical education classes promote the health, psychological well-being and healthy body weight of children, which positively influences both academic learning and physical activity patterns of children; and

WHEREAS, The State Board of Education should be commended for its efforts in promoting healthy habits and establishing the Statewide School Wellness Policy that, beginning with the 2006-2007 school year, requires all school districts to designate at least 30 minutes each school day for physical activity; and

WHEREAS, The Nevada Healthier Schools Project, conceived by Nevada Action for Healthy Kids, offers support, training and resources to public schools in this State in successfully implementing the Statewide School Wellness Policy; now, therefore, be it

RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE ASSEMBLY CONCURRING, That the members of the 74th Session of the Nevada Legislature hereby recognize the need to include physical education, physical activity and recess in public schools; and be it further

RESOLVED, That the members of the 74th Session of the Nevada Legislature hereby urge each public school and each school district in this State to:

- 1. Abide by the requirements set forth in the Statewide School Wellness Policy and seek the services and support of the Nevada Healthier Schools Project in carrying out the Policy;
- 2. Ensure that the current amount of time allocated for physical education, physical activity and recess is not reduced and strive to expand the amount of time allocated each school day for physical education, physical activity and recess; and
- 3. Engage creative measures to provide additional opportunities for physical activity each school day with the goal of ensuring that pupils do not spend more than 90 minutes at any given time sitting sedentary; and be it further

RESOLVED, That the Secretary of the Senate prepare copies of this resolution for transmission by the Legislature to the Superintendent of Public Instruction, each superintendent of a school district in Nevada, the president of the board of trustees of each school district and the coordinator of the wellness program of each school district.

Senator Wiener moved the adoption of the resolution.

Remarks by Senator Wiener.

Senator Wiener requested that her remarks be entered in the Journal.

I am grateful for the opportunity to talk with you, today, about a subject that is very important to me, promoting physical activity in Nevada's schools. Since I was first elected to the Nevada State Senate in 1996, I have been passionate about health issues especially preventative measures.

As you will remember, from 2003 to 2004, I chaired the interim subcommittee to study the impacts of obesity. Additionally, during the 2005 Legislative Session, I successfully sponsored Senate Bill 197. This law directed Nevada's Health Division to establish multiple statewide programs to advance the fitness and overall wellness of Nevada citizens. Today, I stand before you to urge your support for Senate Concurrent Resolution No. 9 to establish Nevada as a model for other states to follow. We know that many states are cutting recess, physical education and activity time. Senate Concurrent Resolution No. 9 encourages Nevada school districts to sustain or increase the amount of time allocated for physical activity in our schools.

Currently, Nevada's State Board of Education, through its statewide school Wellness Policy, requires all school districts to designate at least 30 minutes each school day for physical activity. This is a step in the right direction. However, I believe that we need to take additional steps to promote physical activity in our schools.

Why?

Because, obesity among children has reached a critical level. At present, one in four children is overweight or at risk for becoming obese. The health risks associated with obesity are endless. They are arthritis, cardio-vascular disease, diabetes, gallbladder disease, hypertension, stroke, cancer and other physical disorders. Obesity is second only to tobacco as the leading cause of preventable death, and according to many sources, obesity is quickly taking the lead.

Some people believe that recess and physical education take needed time away from the classroom. In reality, promoting physical activity in schools produces substantial benefits for both students and teachers. In fact, several studies have proven that students who are regularly engaged in physical activities perform better scholastically.

Parents across the country appreciate the importance of regular vigorous physical activity. In fact, 78 percent of parents in the United States believe that time allocated for physical education and recess should not be reduced.

As we consider Senate Concurrent Resolution No. 9, I ask you to take a moment to reflect on what recess and physical education meant to you when you were a child. Remember what it was like to be a ten-year-old. If you were like me, P.E. and recess gave you a chance to release the pent-up energy that had built up in your body as you sat at your desk. Daily physical activity helped you release that energy through exercise, games or sports. This also reenergized you and your classmates to focus on academics when you returned to the classroom. Regular exercise very likely made you a more productive student. It also gave you the opportunity to learn skills in team building, leadership, communication and negotiations. In addition, sharing activities with your friends gave you the opportunity to grow those friendships.

We know that healthy children are healthy learners. An active and balanced lifestyle produces mental and physical well-being. Unfortunately, the habits that contribute to sedentary lifestyles are deeply imbedded in our institutions, our schools, our workplaces and our home environments. Supporting physical activity in our schools through physical education and recess is a crucial step towards ensuring the health and well-being of present and future generations of Nevadans.

This is why I urge your support for Senate Concurrent Resolution No. 9. Thank you.

Resolution adopted.
