Senate Concurrent Resolution No. 16—Memorializing respected horticulturist and longtime Las Vegas resident Aggie Roberts.

WHEREAS, The residents of the City of Las Vegas are mourning the loss of Aggie Roberts, a beloved resident of more than 60 years; and

WHEREAS, Aggie Roberts was very involved in many civic projects such as the Metropolitan Beautification Committee and the Southern Nevada Clean Communities, and was a First Communion teacher for more than 40 years in several parishes in the Diocese of Las Vegas, also serving as a Eucharistic minister; and

WHEREAS, When Aggie was hired as a horticulturist with the University of Nevada Cooperative Extension, where she was employed for 29 years, she had the best of both worlds in that she could combine her lifelong passion for gardening with her career, focusing mainly on media and education; and

WHEREAS, Aggie had such enthusiasm for gardening that she loved to share her knowledge with others by teaching classes whenever called upon and by writing articles and appearing on local television and radio, and her dedication was demonstrated when her house burned down and she lost everything, but she still planned to teach her classes the next day; and

WHEREAS, Known as the "Plant Lady" and for dressing up like a bumblebee or ladybug, Aggie's love of children was exhibited by her many years of participation in the Parent Teacher Association, the Jaycee State Fair, the Girl Scouts of the USA and the Boy Scouts of America, and by forming junior garden clubs in which she included children with disabilities, and in 1996 the Aggie Roberts Elementary School was named in her honor; and

WHEREAS, Aggie lived by her favorite quote, "From what we get, we can make a living; what we give, however, makes a life," and she will be greatly missed for the beauty that she brought to Las Vegas through her gardening, her dedication to the children of her community and her enthusiasm for life; now, therefore, be it

Remarks by Senators Woodhouse and Care.

Senator Woodhouse requested that the following remarks be entered in the Journal.

## SENATOR WOODHOUSE:

I am honored to present this resolution memorializing Aggie Roberts. Appropriately, she is one of the women selected for an exhibit currently showing in the Joseph Anderson Art Gallery

at the State Library and Archives,"100 Years of Influence: The Role of Women in Shaping the First Hundred Years of Las Vegas."

As a French philosopher once said, "All gardeners live in beautiful places because they make them so." Aggie chose to bloom in, and beautify Southern Nevada. What good fortune this was for the people of Clark County especially those who knew her but even those who did not.

Aggie was a giver in the best sense of the word. Family members and friends, students and plants all flourished under her attention and care. Enthusiasm, initiative and dependability are reflected in every aspect of her full life.

The resolution before you, today, recognizes only a few of Aggie Roberts' many accomplishments and contributions. Briefly stated, she was a devoted mother, faithful Catholic, dedicated volunteer, expert horticulturist and teacher extraordinaire.

Newspaper articles have tried to capture the essence of this remarkable woman. She has been called "a breath of fresh air." A writer described her "magic touch" with plants and with people.

Today, if you "Google" Aggie's name on the Internet, you will find articles and brochures she wrote. Topics include tending houseplants and landscaping successfully in the challenging desert climate. As you read her words, you will notice something. Aggie's instructions do not just say how to do something, they say, why.

Even the mission statement on the Web site of Aggie Roberts Elementary School, named in her honor and opened in 1996, reflects the perspective of this mother of three, who taught 5,000 youngsters a year about the miracles of gardening. It reads; "Our mission is to develop independent, secure individuals, capable of adapting to an ever-changing world. We will teach essential skills and promote a personal lifelong love of learning."

Let me offer you a small bouquet of highlights from a life lived well.

More than 60 years ago, Aggie Roberts moved to Nevada to get married. She fell in love with the desert, and the plants that survived its unforgiving conditions fascinated her. She especially enjoyed the Texas Rangers. These desert shrubs have small, silvery velvet leaves and bell-shaped lavender or white flowers that burst forth with new vigor after a rain.

As a parent, Aggie defined her duties broadly. For example, she was a room mother at her children's schools, a leader in the Boy Scouts and Girl Scouts, a superintendent of the Jaycee State Fair, a first Communion teacher and President of 16 PTA organizations.

Aggie Roberts worked for 29 years at the University of Nevada Cooperative Extension even though she never applied for the job. Rumor had it that some woman was giving popular talks at local garden clubs. The Cooperative Extension's director told Aggie's future boss to check this woman out. Aggie easily passed muster and was hired as a horticulturist. As the director said, "She might just as well be getting paid for giving talks as doing them for the love of it."

No manager could confine Aggie to her contracted 40 hours a week. Sixty hours was more her speed. When she worked overtime, she simply switched "hats" and attributed the hours to garden-club activities.

As a teacher, Aggie must have adhered to the adage, "Good teaching is one-fourth preparation and three-fourths pure theatre." Why else would she dress up as a butterfly or a ladybug? Or teach a lesson called "The Talking Plant"?

Youngsters loved the woman they called "The Plant Lady," and no wonder, even in photographs, her eyes sparkle with warmth and a hint of secrets to impart.

Aggie kept her own problems private, although she had her share. She lost her home and belongings in a fire. Her husband died in an automobile accident. Her faith sustained her and so did working in her garden where she felt close to God. "My garden does so much for me," she said, "and it has never let me down. The garden is the best place to go. I always forget everything when I am working in it."

Aggie once said, "I just wish I could be three people, because I don't have enough time to help everyone." Time on earth ran out for her on May 16, 2006, 29 years to the day after she joined the Cooperative Extension.

Second grader Tiffany Theophil surmised the students' feelings about their namesake at a memorial service at the school: "Mrs. Aggie Roberts was the one who made us think harder in different ways. That is what made her special."

She had hoped to attend the Arbor Day celebration at Aggie Roberts Elementary School last spring. This was not to be.

There is an old Shaker saying Aggie might have liked, "If you would have a lovely garden, you should live a lovely life. "Aggie showed us how to do both.

Next month, the students at Aggie Roberts Elementary School will celebrate another Arbor Day. The seasons will change. Plants and people will thrive and struggle. Life will go on, of course, but not completely without the presence of Aggie Roberts.

As someone once said who must have known someone like her, "The true meaning of life is to plant trees under whose shade you do not expect to sit."

In conclusion, a coworker at the Nevada Cooperative Extension penned this tribute to Aggie Roberts:

"Teacher, friend, mentor, and sage.

How can we ever thank you enough for the care you've given?

May the seeds you've sown reap beauty for many years.

Now watch over this garden you've planted from above. "

I would like to thank nursery manager, Sarah Haymond, foresters Rick Vegan and Keith Davis, Nevada Division of Forestry Nursery, for providing the plants on the Senators' desks today in memory of Aggie Roberts. This nursery opens in May, and I encourage all of you to visit the nursery. It is fabulous. Thank you.

#### SENATOR CARE:

Thank you, Mr. President. I cannot improve on the resolution and the remarks made by Senator Woodhouse, but I would like to state briefly that I knew Aggie Roberts for an excess of 20 years. If you ever listened to the radio in Las Vegas, you might have heard her voice that was so instantly recognizable, a voice telling you how to plant flowers that would grow in the desert. When in Las Vegas, drive to the Winchester Recreation Center, which has the desert demonstration garden. This garden is the first of its kind to go into a recreation center. Aggie had a lot to do with its development.

Remarks by Senator Care.

Senator Care requested that his remarks be entered in the Journal.

Thank you, Mr. President. This resolution read here, today, is crafted with reverence but, nonetheless, impossibly inadequate. This resolution is graced with 35 names. Each one of those names brings to mind an image of someone's child, spouse or relative. The images of 9/11 and the images of Operation Enduring Freedom, Operation Iraqi Freedom and the toppling of the statue of Saddam Hussein are forever fresh in our memories. I say images because with Vietnam we learned that repeated televised images can lead to a disturbing distancing between the soldiers who go to war and the citizens for whom the soldiers are engaged in that conflict. We resolve today that that not happen again.

The War on Global Terrorism, as it has become known, has produced untold heroics, but it has also produced abundant heartache. I say that because this heartache is often overlooked. It touches comparatively few of us. Each of the families of these fallen knew that someday the

uniformed messenger might come knocking at their door, and indeed, that is what happened to them.

Most of the names of the fallen listed in this resolution were only beginning to explore adulthood. Most never knew marriage, divorce, parenthood, wealth, bankruptcy and all the misadventures and serendipitous gifts that fall upon us during the course of a lifetime. They will never know nor experience the wisdom and maturation that comes to us during the last years of our lives. Toward the end, we can look back upon our lives and say, life is beautiful. These fallen soldiers cannot say that, but we can thank them for making it possible for us to do so. The families of these fallen soldiers will live for decades, and they will be left to ponder, "what if he/she had come home ...?" The answers will never be known. I say this because sacrifice is not of the moment; it is enduring. We must remember their sacrifice and the incalculable extent to which it was given. That is what we do today, Mr. President, on this advent of spring's rebirth.
