WHEREAS, Jelindo Angelo "J. A." Tiberti was born on April 8, 1919, to hard-working Italian immigrants who lived and worked in the coal mining town of Morley, Colorado, until the family moved to Detroit in 1934; and

WHEREAS, In addition to running J.A. Tiberti Construction, one of the most successful businesses in the country, J. A. was involved in the growth of the area as a member of the Las Vegas Planning Commission for 25 years and the Board of Directors of the Nevada Power Company for 36 years; and

WHEREAS, A man generous with both his time and his money, J. A. Tiberti was active in various professional and philanthropic organizations, including the Las Vegas Rotary Club, the Roman Catholic Diocese of Las Vegas Finance Committee, the Associated General Contractors of America, the Nevada Society of Professional Engineers, and the University of Nevada, Las Vegas, Foundation and Palladium Society; and

WHEREAS, A loving father who taught honesty, generosity and ambition by example, J. A. Tiberti is survived by his sons Tito, Renaldo, Mario and Jelindo, daughters Laura and Andra, sister Rosina Peterson, and numerous grandchildren and great-grandchildren; now, therefore, be if

Senator Raggio requested that the following remarks be entered in the Journal.

SENATOR RAGGIO:

This is a significant day in the Senate. Over the years, we have recognized many prominent individuals for their contributions to this State. Many have passed on. Today we have two. This resolution memorializes an entrepreneur and philanthropist, Jelindo Angelo (J.A.) Tiberti. He lived in Las Vegas for 65 years. No one has made more of an imprint upon the Las Vegas Valley than J.A. Tiberti and his family. The J.A. Tiberti Construction Company was one of the most successful businesses not only in Las Vegas but also in this Country. His hand was in so many projects that a person can now drive anywhere in the Valley and see his work.

He was a remarkable person. I met him many years ago. I recall my last meeting with him when Governor Guinn and I visited. I admit we were trying to get a contribution, but the conversation turned to our Italian background. I have often thought there are two types of people in this world—those who are Italian and those who wish they were. We entered into a long conversation about each of our backgrounds. It was one of the most interesting few hours that I have spent.

We lost this good man on May 3, 2006. He was a warm individual, easy to talk with. I am certain his style has rubbed off on his family.

In addition to the construction industry where he was a leader, he was involved in the growth of Las Vegas. When he first came there, he never imagined that Las Vegas would develop into the city it is today. He was responsible for much of the growth. He was involved in professional and philanthropic organizations and gave to many. Many are indebted to him. It is appropriate that we honor this man who was involved in many activities such as Rotary, Association of General Contractors, Society of Professional Engineers, the University of Nevada, Las Vegas Foundation, to name a few.

Please join in memorializing this great contributor, family man, philanthropist and builder.

SENATOR COFFIN:

Thank you, Mr. President. I find it difficult to follow Senator Raggio when he is speaking so eloquently about Italians and the public in general.

Over the years that I knew J.A. Tiberti, I could only call him Mr. Tiberti. I grew up in the same church attended by Mr. Tiberti and his family. I grew up with Tito who has joined us here today. Mr. Tiberti was kind to all of us kids. I wish I could insert into the record today the tributes I heard a year ago at the funeral from the closest friends of Tito and Laura and the other brothers and sisters. They told of how Mr. Tiberti was a father figure to them even though he was an authoritarian person; there was only one-way to do things. He gave advice whether it was solicited or not. I did not fall into that sphere of influence. I kept my distance. He was truly a leader in our church. He always helped to build things for free. You could not get him to accept payment not even to reimburse him for the cost. He built at least one church I knew of. I think he did the majority of the work on Bishop Gorman High School. As I think back on those days, everything he touched turned to gold. Everything he gave came back to him, fulfilling the old biblical proverb. The riches were returned because he gave riches to all of us. Later on in life, when I ran for public office, he was one of the first people I approached. I came to him and said, "Mr. Tiberti," he stopped me, then, and said, "Call me J.A. It is time. I know why you are here. You want my support. You have it. Not only that, but I will make certain the Associated General Contractors supports you."

It was that way through the years. We never grew distant, though I did not see him as often as I would have liked. He truly was a great man. Thank you.

Senate Concurrent Resolution No. 24—Memorializing business and civic leader James Cashman Jr.

WHEREAS, December 5, 2005, was a day marked with sadness as the City of Las Vegas and the State of Nevada mourned the passing of James Cashman Jr.; and

WHEREAS, James Cashman Jr. was born in Las Vegas on February 19, 1926, to Leah and "Big Jim" Cashman and was introduced to his father's business at the young age of 14 when he began learning about the automotive part of Cashman Enterprises by working in every department; and

WHEREAS, Jim Cashman Jr. graduated from Las Vegas High School 6 months early in December 1943 and immediately enlisted in the United States Army Air Corps where he served as a gunnery instructor in Texas during World War II until 1945 when he returned to Nevada and married Mary Carmichael; and

WHEREAS, At the age of 22, Jim Cashman Jr. became involved in the community by joining the Las Vegas Chapter of the Junior Chamber of Commerce, which named him Outstanding Young Man of 1955, and in his years with the Jaycees he proved his leadership abilities by becoming the state President and the national Vice President of that organization; and

WHEREAS, Even after taking over the helm of Cashman Enterprises upon the death of his father in 1962, James Cashman Jr. still found time to continue his community service by accepting the positions of Chairman of the United Fund Drive in 1969, Chairman of the Las Vegas Chamber of Commerce in 1971 and 1972, President of the United Way of Clark County in 1974, and charter member of the Boys & Girls Clubs of Las Vegas; and

WHEREAS, Recognized as a Distinguished Nevadan by the University of Nevada Board of Regents in 1972, Jim's modest explanation for all he did for Las Vegas and the State of Nevada was that the town and the State had been good to him and his family and he had a debt to repay; and

WHEREAS, Preceded in death by his son James Cashman III in 1995, James Cashman Jr. is survived by his wife Mary, son Tim, daughters Rhonda Evans and Leah Benjamin, daughters-in-law MaryKaye Cashman and Denise Cashman, son-in-law Michael Benjamin, and many grandchildren and great-grandchildren; now, therefore, be it

Remarks by Senators Raggio and Coffin.

Senator Raggio requested that the following remarks be entered in the Journal.

SENATOR RAGGIO:

We are honoring, today, Jim Cashman Jr. who gave so much to this State. I first came to know Jim Cashman in the 1950s. We did many things together. At that time, he was active in the Junior Chamber of Commerce. I had occasion, on a number of times, to go J.C.s for some of their events, and I got to know several sides of Jim Cashman. They were all exciting. We had some great times together and that friendship continued until his death. Though he and I were born the same year, he was a little older and I often reminded him that I always looked up to my elders.

Like the Tiberti family, the Cashman family was probably one of the most prominent families during the development of Las Vegas. The Cashman family in Las Vegas goes back to his father, "Big Jim" Cashman. Jim joined his father's business when he was 14 years old. He started learning about Cashman Enterprises. At that time, Las Vegas was a very small place, not the city you see today. It was a small town. It was not until 1956 that Las Vegas surpassed Reno as the largest city in the State. Jim grew up in Las Vegas. He went to high school there. He joined the Army Air Corp during WWII. When he returned, he married Mary Carmichael. They were married for almost 61 years until his death.

Jim Cashman had a particularly distinguished service in the Junior Chamber of Commerce becoming one of its national officers. He was recognized nationally for his many achievements. You could find Jim in almost every significant activity in Clark County over the years. He served as President of the United Way. He was one of the founders of the Boys and Girls Club. He was a distinguished contributor to the University System in southern Nevada as well as in the State and was recognized by the University of Nevada as a Distinguished Nevadan. He was always one who contributed but never wanted the recognition. He was a modest person. He would snarl at you if you thanked him and would say, "It was nothing." He never said "no." If you asked him, you could always count on Jim Cashman for not only financial support but for other support as well. He would support any good cause and any good effort.

He loved this State. Jim spent some time in Montana at the ranch, but he was a Nevadan through and through. With his passing, we lost a distinguished Nevadan; someone who, like our previous honoree, made such an imprint upon this State and that tradition is carried on by his family. We appreciate all of his efforts, and we memorialize the life of a great Nevadan, Jim Cashman Jr.

SENATOR COFFIN:

Thank you, Mr. President. We honor another person whose first name was "Mister." It occurs to me that is the only name I could call him for many years.

I started playing golf in 1956 at the age of 13. Mr. Cashman played the golf course at the Desert Inn Country Club. He would, also, play frequently at the municipal course. He was a dear friend of the head professional there, the late John DiFloure. He would often come with his good friend, Art "Smitty" Smith, whose daughter, Barbara Smith Campbell, is with us today. I remember how down to earth he was. He would be very friendly with us kids. He would call us by our first names, and I even caddied for him once. I learned much during that round of caddying. It is important to note that he was a member of the Junior Chamber of Commerce and that means a certain type of wisecracking, wild character. I learned a lot from him in that respect. I was able to travel the Country to two different golf tournaments because of Jim's contributions through the Junior Chamber of Commerce. Jim helped cosponsor and fund the Junior Chamber of Commerce Annual Golf Tournament nationally. I was able to travel to Washington D.C. and Norfolk, VA for a tournament when I was 16 years old and to Waterloo, Iowa, when I was 17 years old. This was during the years when Jim was very active in the Junior Chamber of Commerce supporting golf.

I knew him as the parent of my friend Jim III who suddenly died. I do not know how he and Mary survived that shock, but they did. I knew him through the Bishop Gorman High School

connection through Jim III and his sister. We all have fond memories of church and school associated with Mr. Cashman and his contributions. I was not even 30 years old when Jim invited me to join the Board of Directors of the Nevada State Golf Association. I was 20 years younger than the next youngest person on the Board. That was rarified company because it was composed of business leaders of northern Nevada and southern Nevada. It was a true, blue cashmere jacket society. I was awed by that experience and always grateful to him for that.

Mary, I am so glad to see you here, today. I was always amazed that you could tolerate all the flying he did. We were in Death Valley once at the annual golf tournament end of season. It occurred just before the heat hit when they would turn the golf course back to pasture letting horses and mules graze on it. Jim was always active in not only the tournament but in the Calcutta the night before. John DiFloure was the auctioneer and Jim bought half of the teams. Somehow or another, the party lasted all night and well into the next day. Jim flew in at about 100 feet altitude with DiFloure and came in low and fast over the golf course in a twin-engine plane waving his wings, and I thought he was going to hit a palm tree. Luckily, he did not land on the fairway. There was a strip not too far away. He was able to land despite his condition, which seemed safe enough to fly, though, perhaps, not to drive. These are some of the wonderful memories I have of the great Jim Cashman. Thank you.

Assembly Concurrent Resolution No. 21—Commending the Nevada Division of the National Pony Express Association for its efforts in keeping the memory of the Pony Express alive in Nevada.

WHEREAS, With the discovery of gold in the West in 1848 and the increasing political tensions of the 1850s, it became imperative to keep California aligned with the Union by providing a faster and more dependable source of information from the northeastern states; and

WHEREAS, William H. Russell, Alexander Majors and William B. Waddell took on the challenge and, in the short span of 2 months, set up a mail delivery system that was named the Pony Express; and

WHEREAS, The sacrifice of the station masters, many of whom gave their lives, and the dedication, bravery and horsemanship of the wiry riders as they carried the mail for almost 2,000 miles from St. Joseph, Missouri, to Sacramento, California, across scorching deserts and through deep snow in 10 days is legendary, and the tales of their daring and loyalty are part of the history and lore of the American West; and

WHEREAS, Although in operation for only 18 months, this amazing venture bound the ragged edges of a rising nation and stands in history as a monumental example of the vision, courage and character of the men and women who built the West; and

WHEREAS, The route of the Pony Express runs through portions of eight states, and in Nevada roughly parallels U.S. Highway 50, the surrounding area of which has been dubbed "Pony Express Territory" by the Commission on Tourism; and

WHEREAS, In addition to being part of a reenactment ride held each year in June, the members of the Nevada Division of the National Pony Express Association keep the story and spirit of the Pony Express alive by marking and preserving the Nevada portion of the trail, participating in community events and giving educational presentations to schools and other groups; and

WHEREAS, Principally through the efforts of Larry McPherson, past President of the Nevada Division, a historical marker consisting of a silhouette depicting a Pony Express rider and horse will soon stand along U.S. Highway 50 east of Carson City as a reminder of this important part of Nevada history; now, therefore, be it

RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE SENATE CONCURRING, That the 74th Session of the Nevada Legislature commends the Nevada Division of the National Pony Express Association for its contributions toward preserving the history and making visible the spirit of the Pony Express in the State of Nevada; and be it further RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy of this

Remarks by Senator Amodei.

Senator Amodei requested that his remarks be entered in the Journal.

Thank you, Mr. President. It is interesting to look at the route of the Pony Express and think about the role it played in the history of our Country. The portion of the route that goes through our Silver State is still largely as it was in the 1860s.

I had the privilege, during my younger years, to work at a summer job for the Bureau of Land Management (BLM) in the Youth Conservation Corps. One of our projects for the bicentennial into the mid 1970s was to mark the Pony Express route in the State of Nevada. After the archeologists were sent out to retrace the route, the details of which are still controversial, our job was to go every mile and put a 4x4 post with an "XP" branded on the top if it. Then, at the passes, they planted a concrete post to mark that route. Because of the distance involved, the BLM sent out high school juniors and seniors to spike camps where we would drive our trucks around the countryside and mark the trail. I have some of my best memories from that summer. We did not know what a great job we had even though I think I made about as much as I do being a member of the Nevada Legislature. We camped at these locations as we worked our way across, and when night came, I could not see another light anywhere from horizon to horizon. I pulled up at stations with names like Hootin' Wells, Sand Springs and Cold Springs. I think all are in the Central Senate District. This is where I camped for the night, and I got out, looked around and saw a dead cow, dead kit fox, dead magpie, and I wondered if the next dead thing would be the people who camped there that night since evidently the water was not so good at

I look at that trail and try to imagine what it was like back then, 150 years ago. When we do the reenactments our guests are involved in, it is obvious it really does not look much different than it did then. This is a special thing about the Nevada segment of the Pony Express.

The Pony Express stations, many of which are still standing, were made with rock walls made without mortar with gun ports in them. There are stories about the difficulty with the natives and other hardships of the West and the epic rides through Nevada and about a man named "Pony" Bob Haslam, who I am certain is related to someone in this body, riding through the country under attack. The Pony Express is a piece of our history that has endured largely because Nevada exists as it did back then. I urge your support of Assembly Concurrent Resolution No. 21.

REMARKS FROM THE FLOOR

Senator Woodhouse requested that her remarks be entered in the Journal.

Statistics show that in 1963, women earned about 59 cents for every dollar earned by men. In 2005, women earned about 77 cents for every dollar earned by men. Though wage earning by women appears to have increased during the past 40 years, the wage gap has narrowed by less than one half cent per year.

In 1979, the National Committee On Pay Equity was founded, forming a coalition at state and local levels to eliminate wage discrimination and achieve pay equity by closing the wage gap between men and women and people of color.

Each year, the committee organizes the observance of Equal Pay Day on Capitol Hill in Washington D.C., as a day for national recognition of the wage gap. This year, Equal Pay Day was observed yesterday, April 24, 2007.

Promoting awareness of the wage gap is advocated by the Nevada branch of the American Association of University Women, a national organization that promotes education and equity for all women and girls.

I would like to recognize the efforts made by the American Association of University Women in bringing attention to the wage disparity that still exists today.

I am happy to present this proclamation to my guests and Senator Titus' guest from the Nevada Branch of the American Association of University Women and applaud their continuing efforts to achieve equal pay for women.
