BDR 34-277—Creates and funds new higher education scholarship programs.

BDR 34-531—Revises provisions governing education and makes appropriations relating to education. (Later introduced as [Assembly Bill 563](#).)

BDR 34-918—Revises provisions governing university schools for profoundly gifted students. (Later introduced as [Assembly Bill 567](#).)

BDR S-984—Provides for access to computers to underserved pupils and their families to increase literacy. (Later introduced as [Assembly Bill 566](#).)

BDR 34-1369—Revises provisions governing the compensation of teachers and other licensed educational personnel. (Later introduced as [Assembly Bill 568](#).)

BDR 34-1371—Revises provisions governing educational finance. (Later introduced as [Assembly Bill 565](#).)
