#### Chair Leslie:

Described each Bill Draft Request (BDR) and requested that all of the BDRs be moved for introduction in one motion.

- BDR 38-1432—Provides for elimination of obsolete statutes pursuant to NRS 218.2473. (Later introduced as Assembly Bill 575.)
- **BDR 38-603**—Revises provisions governing the licensing and regulation of agencies that provide personal assistance for persons with disabilities. (Later introduced as <u>Assembly Bill 576.</u>)
- BDR 40-1035—Makes certain changes relating to the handling of patients with limited mobility. (Later introduced as Assembly Bill 577.)
- **BDR 40-275**—Revises provisions governing informed consent for human subject research. (Later introduced as Assembly Bill 578.)
