- **BDR S-1205—Makes an appropriation to the Office of the State Controller for the purchase of computer hardware and software. ([Assembly Bill 197](#).)**
- **BDR S-1251—Makes a supplemental appropriation to the Department of Health and Human Services, Administration, to fund leased office space and tenant office improvements. ([Assembly Bill 198](#).)**
- **BDR S-1253—Makes a supplemental appropriation to the Office of Health Administration of the Department of Health and Human Services to fund Poison Control Call Centers. ([Assembly Bill 199](#).)**
- **BDR S-1265—Makes an appropriation to the Information Technology Division of the Department of Administration to add sites and enhancements to the 800 MHz radio system. ([Assembly Bill 200](#).)**



- **BDR S-1246**—Makes a supplemental appropriation to the Budget Division of the Department of Administration for overtime and increased costs. ([Assembly Bill 201.](#))
- **BDR S-1220**—Makes an appropriation to the State Gaming Control Board for implementation of security measures and replacement of equipment. ([Assembly Bill 202.](#))
- **BDR S-1212**—Makes an appropriation to the Grants Management Unit of the Department of Health and Human Services for the benefit of Family Resource Centers. ([Assembly Bill 203.](#))
- **BDR S-1210**—Makes an appropriation to the Department of Education for video and computer equipment. ([Assembly Bill 204.](#))
- **BDR S-1208**—Makes an appropriation to the Department of Administration for the purchase of motor pool vehicles. ([Assembly Bill 205.](#))
- **BDR S-1207**—Makes an appropriation to the Department of Administration to fund certain information technology projects. ([Assembly Bill 206.](#))
