The meeting is now open. The Committee has received a one-page document titled "Senate Finance Bill Introductions, March 8, 2007" (<u>Exhibit A</u>). I am requesting Committee introduction of the following bill draft requests (BDR) listed on Exhibit A:

- BILL DRAFT REQUEST 1-663: Revises provisions concerning supreme court and district court judges in Nevada. (Later introduced as Senate Bill 248.)
- BILL DRAFT REQUEST 5-653: Revises formula for funding of certain youth camps. (Later introduced as Senate Bill 249.)
- BILL DRAFT REQUEST S-1226: Makes appropriation for replacement of old, high-mileage vehicles and purchase of an ATV/tractor, drain and duct inspection equipment and miscellaneous custodial equipment. (Later introduced as Senate Bill 250.)
- BILL DRAFT REQUEST S-1221: Makes an appropriation for the Department of Conservation and Natural Resources Water Resources, Forestry, Forestry Conservation Camps and State Parks, for replacement vehicles and computer equipment and various other projects. (Later introduced as Senate Bill 251.)
- <u>BILL DRAFT REQUEST S-1217</u>: Makes an appropriation for the Welfare Services for replacement of aging computer and telephone equipment. (Later introduced as <u>Senate Bill 252</u>.)
- BILL DRAFT REQUEST S-1215: Makes an appropriation for various mental health departments and centers in the Department of Health and Human Services to replace computer hardware and software, furniture and equipment, and vehicles. (Later introduced as Senate Bill 253.)

- BILL DRAFT REQUEST S-1229: Makes appropriation for Clark and Washoe Counties Education Foundations to fund new programs and the expansion of outreach efforts (Later introduced as Senate Bill 254.)
- BILL DRAFT REQUEST S-767: Makes appropriation to High Sierra Industries (HSI) to be used for facilities to support, train and employ persons with disabilities. (Later introduced as Senate Bill 255.)
