### CHAIR AMODEI:

We call this meeting of the subcommittee of the Senate Committee on Judiciary to order and open the hearing with Assembly Bill (A.B.) 90.

ASSEMBLY BILL 90 (1st Reprint): Creates the crime of paternity fraud. (BDR 15-147)

ASSEMBLYWOMAN SUSAN GERHARDT (Assembly District No. 29): I present to this Subcommittee my written testimony (Exhibit C).

ED EWERT (Chief Deputy District Attorney, Family Support Division, Clark County):

I present to the Subcommittee my written testimony (<u>Exhibit D</u>). I, as well as others in my office, wish to express our support of A.B. 90.

## CHAIR AMODEI:

Assemblywoman Gerhardt, what are your thoughts on misdemeanor versus gross misdemeanor?

## ASSEMBLYWOMAN GERHARDT:

It should be a gross misdemeanor, but there was some reluctance in our committee and a mood to not burden the system.

## CHAIR AMODEI:

Let your colleagues know that when we work session this bill, the issue will be misdemeanor versus gross misdemeanor. Is there more testimony for A.B. 90?

PAULA BERKLEY (Nevada Network Against Domestic Violence): We support this bill.

KRISTIN L. ERICKSON (Nevada District Attorneys Association): I would like to give my support for this bill.

### CHAIR AMODEI:

Do you have any thoughts on misdemeanor versus gross misdemeanor?

### Ms. Erickson:

The differences between the two are a misdemeanor is six months in Washoe County jail and a \$1,000 fine whereas a gross misdemeanor puts it into district court for a formal probation and increases the penalty to one year in jail along with a \$2,000 fine.

JULIANNA ORMSBY (Nevada Women's Lobby): We urge your support for A.B. 90.

LOUISE BUSH (Chief, Child Support Enforcement, Division of Welfare and Supportive Services, Department of Health and Human Services):

I have given the Subcommittee my written testimony (Exhibit E).

#### CHAIR AMODEI:

Is there anyone else to testify on  $\underline{A.B. 90}$ ? We will close the hearing on  $\underline{A.B. 90}$  and open the hearing on A.B. 20.

ASSEMBLY BILL 20 (1st Reprint): Revises the provisions pertaining to travel costs that jurors are entitled to receive. (BDR 1-323)

ALAN GLOVER (County Fiscal Officers Association):

This bill was the result of a discussion at an annual meeting of clerks. After gathering information from jurors and potential jurors, it was a burden on people to serve for those who travel great distances. It was proposed to amend the travel allowance to compensate the travel time.

## CHAIR AMODEI:

Are there any questions for Mr. Glover?

George Ross (Las Vegas Chamber of Commerce):

It is a fundamental right to serve as a juror, and A.B. 20 will help broaden the pool of jurors. We are in favor of this bill.

We will close the hearing on A.B. 20 and open the hearing on A.B. 117.
