EDWIN D. JAMES (Carson Water Subconservancy District):

I have Eugenia Azad with me today. She is from the Carson Water Subconservancy District (CWSD). We have a PowerPoint presentation without

the power. We are here to give you an understanding of who the subconservancy is and what we do. The CWSD was established in 1959. Legislation was enacted in 1989, chapter 621 *Statutes of Nevada* 1989, that changed the role of the CWSD.

We began by looking at the resources on the Carson River. Our goal was to find an integrated process for watershed planning. I will give you an overview of the presentation (Exhibit C). We do represent all the entities and counties on the watershed. The areas represented are: Douglas County, Lyon County, Carson City, Churchill County and Alpine County, California. The CWSD has a very small staff. We endeavor to maximize resources. There are limited funds. There are many challenges, such as water supply, habitat and water quality, floodplain areas with loss of agricultural lands and flood control. Area groups are working together to resolve these issues. We try to work together with the various concerns of the member entities. We are all one watershed and what happens upstream or downstream, we know, will affect our neighbors.
