Chair McGinness called for committee introduction of Bill Draft Request (BDR) 32-256, BDR 32-399, BDR 32-556, BDR 32-578, BDR 32-579 and BDR 32-1406.

BILL DRAFT REQUEST 32-256: Revises provisions governing taxation of moist snuff. (Later introduced as [Senate Bill 506](#).)

BILL DRAFT REQUEST 32-399: Requires a portion of the proceeds of the basic governmental services tax to be deposited with the State Treasurer for credit to the Trust Fund for the Control of Weeds. (Later introduced as [Senate Bill 505](#).)

BILL DRAFT REQUEST 32-556: Revises various provisions governing sales and use taxes to ensure continued compliance with the Streamlined Sales and Use Tax Agreement and repeals certain obsolete provisions for the administration of those taxes. (Later introduced as [Senate Bill 502](#).)

BILL DRAFT REQUEST 32-578: Revises provisions governing the rate of interest paid on overpayments of certain taxes, fees and assessments. (Later introduced as [Senate Bill 504](#).)

BILL DRAFT REQUEST 32-579: Requires payment of penalty and interest for failure to pay to the Department of Taxation required licensing fees for exhibitions in a timely manner. (Later introduced as introduced as [Senate Bill 503](#).)

BILL DRAFT REQUEST 32-1406: Makes various changes to provisions relating to taxation and nonprofit entities that provide emergency medical services. (Later introduced as [Senate Bill 501](#).)
