AN ACT relating to veterans; requiring the Executive Director for Veterans' Services to prepare, maintain and make available for public inspection a register that includes the names of the veterans interred in each cemetery in this State; requiring the Executive Director to provide flags of the United States to certain persons and civic organizations for placement on the graves of veterans on certain holidays; requiring the Executive Director to provide a flag of the United States to each resident of a veterans' home in this State to commemorate certain holidays; making an appropriation; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 The Office of Veterans' Services provides various services to persons
- 2 serving in the Armed Forces of the United States and veterans and their
- 3 families. (Chapter 417 of NRS) **Section 2** of this bill requires the Executive

4 Director for Veterans' Services to prepare, maintain and make available for
 5 public inspection a register that includes the names of the veterans interred
 6 in the cemeteries in this State. **Section 3** of this bill requires the Executive
 7 Director to provide, without charge, flags of the United States to certain
 8 persons and civic organizations for placement on the graves of veterans on
 9 certain holidays. This bill also requires the Executive Director each year to
 10 provide a flag of the United States to each resident of a veterans' home in
 11 this State to commemorate certain holidays. *Section 4 of this bill*
 12 *appropriates \$15,000 to the Office of Veterans' Services to provide the*
 13 *flags.*

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 417 of NRS is hereby amended by adding thereto the
 2 provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *The Executive Director shall prepare, maintain and make*
 4 *available for public inspection a register that includes the names of the veterans*
 5 *interred in the veterans' cemetery in northern Nevada, the veterans' cemetery in*
 6 *southern Nevada and all other public and private cemeteries in this State. The*
 7 *register must include the number of veterans interred in each cemetery in this*
 8 *State and, if known, the date of interment of each veteran.*

9 **Sec. 3.** 1. *The Executive Director shall, upon the request of the*
 10 *owner or operator of a cemetery in this State or a civic organization recognized*
 11 *by the Executive Director, provide a sufficient number of flags of the United*
 12 *States for placement on the graves of veterans interred in the cemetery to*
 13 *commemorate Memorial Day, Flag Day, Independence Day and Veterans' Day.*
 14 *The flags must be of a size suitable for placement on a grave and provided*
 15 *without charge.*

16 2. *Each year, on or before Memorial Day, Flag Day, Independence Day*
 17 *and Veterans' Day, the Executive Director shall, without charge, provide to each*
 18 *resident of a veterans' home in this State a flag of the United States of an*
 19 *appropriate size for use in commemorating those holidays.*

20 3. *The flags the Executive Director is required to provide pursuant to this*
 21 *section must be manufactured in the United States.*

22 **Sec. 4.** 1. **There is hereby appropriated from the State General**
 23 **Fund to the Office of Veterans' Services to carry out the provisions of section 3**
 24 **of this act:**

 28 2. **The sums appropriated by subsection 1 are available for either fiscal**
 29 **year. Any remaining balance of those sums must not be committed for**
 30 **expenditure after June 30, 2009, by the entity to which the appropriation is**

31 **made or any entity to which money from the appropriation is granted or**
32 **otherwise transferred in any manner, and any portion of the appropriated**
33 **money remaining must not be spent for any purpose after September 18, 2009,**
34 **by either the entity to which the money was appropriated or the entity to**
35 **which the money was subsequently granted or transferred, and must be**
36 **reverted to the State General Fund on or before September 18, 2009.**
