AN ACT making a supplemental appropriation to the Department of Health and Human Services, Administration, to fund leased office space and tenant office improvements; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General Fund to the
2 Department of Health and Human Services, Administration, the sum of ***\$635,000***
3 ***\$603,418*** to fund additional tenant improvements, including window coverings,
4 phone and data cabling, the purchase of modular furniture and rent due for leased
5 office space following the move from the Kinkead Building. This appropriation is
6 supplemental to that made by section 20 of chapter 434, Statutes of Nevada 2005, at
7 page 1939.

8 **Sec. 2.** This act becomes effective upon passage and approval.
