AN ACT relating to school districts; ~~[requiring]~~ **authorizing** the board of trustees of a school district in certain counties to cause each meeting of the board to be televised; and providing other matters properly relating thereto.

1 ~~[This]~~ **Section 1 of this bill** ~~[requires]~~ **authorizes** the board of trustees of a school district
2 in a county whose population is ~~[400,000]~~ **50,000** or more ~~[currently Clark County]~~
3 **(currently Clark and Washoe Counties and Carson City)** to cause each meeting of the
4 board to be broadcast on a television station created to provide community access to cable
5 television by using the facilities of the **school district**, county or any city located in the
6 county. **Section 2 of this bill requires those school districts to provide a report to the**
7 **Legislative Committee on Education and the Legislature concerning the progress of**
8 **the school district in televising the meetings of the board of trustees.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 386.330 is hereby amended to read as follows:
2 386.330 1. The board of trustees shall hold a regular meeting at least once
3 each month, at such time and place as the board shall determine.
4 2. Special meetings of the board of trustees shall be held at the call of the
5 president whenever there is sufficient business to come before the board, or upon
6 the written request of three members of the board.

1 3. The clerk of the board of trustees shall give written notice of each special
2 meeting to each member of the board of trustees by personal delivery of the notice
3 of the special meeting to each trustee at least 1 day before the meeting, or by
4 mailing the notice to each trustee's residence of record, by deposit in the United
5 States mails, postage prepaid, at least 4 days before the meeting. The notice shall
6 specify the time, place and purpose of the meeting. If all of the members of the
7 board of trustees are present at a special meeting, the lack of notice shall not
8 invalidate the proceedings of the board of trustees.

9 4. A majority of the members of the board of trustees shall constitute a
10 quorum for the transaction of business, and no action of the board of trustees shall
11 be valid unless such action shall receive, at a regularly called meeting, the approval
12 of a majority of all the members of the board of trustees.

13 5. *In any county whose population is ~~400,000~~ 50,000 or more, the board of*
14 *trustees ~~shall~~ may cause each meeting of the board to be broadcast on a*
15 *television station created to provide community access to cable television by using*
16 *the facilities of the school district, county or any city located in the county. The*
17 *board of trustees and the county or city shall cooperate fully with each other ~~in~~*
18 *~~arranging for the use of the facilities by the board in carrying out the~~*
19 *~~requirements of this subsection.~~ to determine:*

20 (a) The feasibility of televising the meetings of the board of trustees;

21 (b) The costs to televise the meetings of the board of trustees for each
22 proposed method of televising; and

23 (c) The number of potential viewers of the meetings of the board of trustees
24 for each proposed method of televising.

25 Sec. 2. The board of trustees of each school district in a county whose
26 population is 50,000 or more shall cooperate with the board of county
27 commissioners of the county and the governing body of each city in the county,
28 if applicable, to prepare a written report describing their progress in carrying
29 out the provisions of NRS 386.330, as amended by section 1 of this act. The
30 report must be submitted on or before February 1, 2009, to the Legislative
31 Committee on Education and to the Director of the Legislative Counsel
32 Bureau for transmission to the 75th Session of the Legislature.
