AN ACT making an appropriation to the Department of Health and Human Services for computer software and hardware and other equipment; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General Fund to the
2 Department of Health and Human Services, Aging Older Americans Act, the sum
3 of ~~[\$63,447]~~ **\$52,748** to partially fund the replacement of computer hardware and
4 software and to partially fund the purchase of air-conditioning for server rooms in
5 Reno and Carson City.

6 **Sec. 2.** Any remaining balance of the appropriation made by section 1 of this
7 act must not be committed for expenditure after June 30, 2009, by the entity to
8 which the appropriation is made or any entity to which money from the
9 appropriation is granted or otherwise transferred in any manner, and any portion of
10 the appropriated money remaining must not be spent for any purpose after
11 September 18, 2009, by either the entity to which the money was appropriated or
12 the entity to which the money was subsequently granted or transferred, and must be
13 reverted to the State General Fund on or before September 18, 2009.

14 **Sec. 3.** This act becomes effective upon passage and approval.
