AN ACT making an appropriation to the Legislative Fund for the Legislative Auditor to enter into a contract with a consultant to conduct a performance audit of agencies which provide child welfare services; **requiring the consultant to submit a report of the performance audit to the Director of the Legislative Counsel Bureau;** and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the Legislative Fund created by NRS 218.085 the sum of ~~\$200,000~~ **\$400,000** for
3 the Legislative Auditor to enter into a contract with a qualified, independent
4 consultant to conduct a performance audit of each agency which provides child
5 welfare services.

6 2. The consultant shall perform random unannounced visits to the agencies
7 which provide child welfare services. During ~~such~~ **those** visits, the consultant
8 shall review files of open and closed cases concerning children who have been
9 abused or neglected. The consultant ~~shall~~ shall:

10 (a) Review the manner in which the agencies which provide child welfare
11 services document, respond to and report cases of child abuse or neglect;

12 (b) Review the procedures used by the agencies which provide child welfare
13 services to determine whether to close a case;

1 (c) Determine whether the agencies which provide child welfare services are
2 complying with federal and state laws in the manner in which they carry out their
3 responsibilities with respect to child abuse or neglect;

4 (d) Evaluate the effectiveness and availability of appropriate intervention
5 services;

6 (e) Determine the frequency with which the agencies **which provide child**
7 **welfare services** have direct contact with children placed in foster homes or
8 emergency shelters;

9 (f) Determine whether the agencies **which provide child welfare services**
10 have successfully incorporated the recommendations set forth in the Report of the
11 Clark County Blue Ribbon Panel for the Review of Child Deaths and of the
12 Northern Blue Ribbon Panel for the Review of Child Deaths, as applicable; and

13 (g) Evaluate the progress and efforts made towards meeting the requirements
14 set forth in the federally approved Performance Improvement Plan and Corrective
15 Action Plan.

16 3. **The consultant shall, in determining the frequency with which the**
17 **agencies which provide child welfare services have direct contact with children**
18 **placed in foster homes or emergency shelters pursuant to paragraph (e) of**
19 **subsection 1, determine whether:**

20 (a) The frequency of visits is in accordance with the established policy of
21 each agency which provides child welfare services concerning the frequency of
22 visits to children placed in foster homes or emergency shelters; and

23 (b) The frequency of visits to each child is appropriate for that child.

24 4. **In reviewing the files of open and closed cases concerning children who**
25 **have been abused or neglected, the consultant:**

26 (a) Shall, if he becomes aware of circumstances which he reasonably
27 believes may cause a child to be in imminent danger of abuse or neglect,
28 immediately report those circumstances to the appropriate agency which
29 provides child welfare services; and

30 (b) May interview any relative, foster parent or any other person
31 identified in a case file who may have additional information concerning the
32 case.

33 5. Each agency which provides child welfare services shall:

34 (a) Cooperate with the consultant;

35 (b) Allow the consultant to inspect, review and copy any records, reports and
36 other documents relevant to the duties of the consultant;

37 (c) Provide access to the consultant to any facility within its jurisdiction which
38 has custody of children pursuant to court order; and

39 (d) Allow the consultant to interview members of the staff of ~~such~~ those
40 facilities and children who are in the custody of ~~such~~ those facilities.

41 ~~¶~~ 6. **The independent consultant shall prepare and submit a report of**
42 **the performance audit to the Director of the Legislative Counsel Bureau not**
43 **later than October 1, 2008.**

44 7. As used in this section, "agency which provides child welfare services" has
45 the meaning ascribed to it in NRS 432B.030.

46 **Sec. 2. 1. Not later than October 1, 2007:**

47 (a) **The Legislative Auditor shall enter into a contract with an independent**
48 **consultant pursuant to section 1 of this act; and**

49 (b) **The Legislative Commission shall review the contract.**

50 2. **The contract does not become effective unless approved by the**
51 **Legislative Commission.**

52 ~~See 2.~~ Sec. 3. This act becomes effective on July 1, 2007.
