AN ACT relating to motor vehicles; ~~[authorizing the Department of Motor Vehicles to issue special license plates and registration certificates for custom vehicles; imposing fees for the issuance of those special license plates.]~~
exempting replica vehicles from inspection requirements for the control of emissions; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill authorizes the Department of Motor Vehicles to issue special license plates and
2 registration certificates for custom vehicles, which are vehicles manufactured after 1968 and
3 resemble vehicles manufactured before 1968. This bill provides that a custom vehicle which is
4 not used for general transportation may be registered without the payment of the usual
5 registration fees and governmental services tax, instead requiring an owner of a custom
6 vehicle to pay a specific fee for the issuance of the special license plates. This bill exempts a
7 custom vehicle not used for general transportation from vehicle inspection and emission
8 control inspection requirements. An owner of a custom vehicle may elect to use the custom
9 vehicle for general transportation if the full registration fee and governmental services tax is
10 paid and if the vehicle passes required inspections.**]** Section 1 of this bill provides that the
11 **Department of Motor Vehicles may not register more than 100 replica vehicles per year.**
12 Existing law exempts military tactical vehicles from the inspection requirements
13 required by chapter 445B of NRS. (NRS 445B.759) Section 3 of this bill defines “replica
14 vehicles” and expands the exemption to apply to replica vehicles as well.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Delete existing sections 1 through 7 of this bill and replace with the following
2 new section 1:

3 4 **Section 1.** Chapter 482 of NRS is hereby amended by adding thereto a
4 new section to read as follows:

5 1 *The Department may not issue a certificate of registration for more than
6 100 replica vehicles each year. The fact that the vehicle is to be registered as a
7 replica vehicle must be stated in the application for registration.*

8 2 *For purposes of this section, "replica vehicle" has the meaning ascribed
9 to it in NRS 445B.759.*

10 Sec. 2. NRS 445B.759 is hereby amended to read as follows:

11 445B.759 1. The provisions of NRS 445B.700 to 445B.845, inclusive, do
12 not apply to [military];

13 (a) *Military* tactical vehicles; or

14 (b) *Replica vehicles.*

15 2. As used in this section [“military tactical vehicle”]:

16 (a) *“Military tactical vehicle” means a motor vehicle that is:*

17 1. Owned or controlled by the United States Department of Defense or
18 by a branch of the Armed Forces of the United States; and

19 2. Used in combat, combat support, combat service support, tactical or
20 relief operations, or training for such operations.

21 (b) *“Replica vehicle” means any passenger car or light-duty motor vehicle
22 which:*

23 1. *Has a body manufactured after 1968 which is made to resemble a
24 vehicle of a model manufactured before 1968;*

25 2. *Has been altered from the original design of the manufacturer or has
26 a body constructed from materials which are not original to the vehicle;*

27 3. *Is maintained solely for occasional transportation, including
28 exhibitions, club activities, parades, tours or other similar uses; and*

29 4. *Is not used for daily transportation.*

30 The term does not include a vehicle which has been restored to its original
31 design by replacing parts.

32 Sec. 3. This act becomes effective on July 1, 2007.
