Legislative Counsel’s Digest:

1 Existing law authorizes the county school districts to form the Nevada Interscholastic
2 Activities Association, which controls, supervises and regulates all interscholastic athletic and
3 other events in the public schools. (NRS 386.420-386.470) Under existing law, the
4 Association is required to adopt rules and regulations to carry out its responsibilities,
5 including, without limitation, an adequate process for reviewing and determining disputes.
6 (NRS 386.430, 386.440) This bill provides that a decision of the Association or a designee of
7 the Association that is authorized to make final decisions on disputes ~~is final and not subject~~
8 ~~to judicial review;]~~ **must not be stayed by a court pending the court’s final judgment on**
9 **the matter.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 386.440 is hereby amended to read as follows:
2 386.440 *1.* The rules and regulations of the Nevada Interscholastic
3 Activities Association adopted pursuant to NRS 386.430 must provide for adequate
4 review procedures to determine and review disputes arising in regard to the
5 Association’s decisions and activities.
6 *2. A decision of the Nevada Interscholastic Activities Association or a*
7 *decision of a person designated by the Association to review and make final*
8 *decisions on disputes on behalf of the Association pursuant to the rules and*

1 *regulations adopted pursuant to NRS 386.430 ~~is final and not subject to judicial~~*
2 *~~review.] must not be stayed by a court pending the court's final judgment on the~~*
3 *matter.*

4 **Sec. 2.** This act becomes effective on July 1, 2007.
