AN ACT relating to elections; ~~[eliminating the deadline for registering to vote in an election.]~~ requiring the Secretary of State and the county clerks of each county to study the feasibility of changing the deadline for registering to vote in an election; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides that the period for registering to vote at an election ends at 9 p.m.
2 on the third Tuesday preceding an election. For the period beginning on the fifth Sunday
3 preceding an election and ending on the third Tuesday preceding an election, an elector may
4 register to vote only by appearing in person at the office of the county clerk. (NRS 293.560)
5 This bill ~~[eliminates the deadline for registering to vote for an election and provides that a person may register to vote at the office of the county or city clerk from the period beginning on the fifth Sunday preceding an election until the polls close on election day.]~~ requires the
6 **Secretary of State and the county clerks for each county jointly to study the feasibility of**
7 **changing the deadline for registering to vote to any date closer to the date of the election up to and including election day.** This bill also requires the Secretary of State and the
8 county clerks to submit a report concerning the results of the study to the 75th Regular
9 Session of the Nevada Legislature.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Delete existing sections 1 through 11 of this bill and replace with the following
2 new sections 1 and 2:

Section 1. 1. The Secretary of State and the county clerk of each county jointly shall study the feasibility of changing the deadline for registration of

1 **voters to allow qualified electors to register to vote in an election on any date
2 closer to the election up to and including the date of the election;**

3 **2. The study conducted pursuant to subsection 1 must include, without
4 limitation, an analysis of:**

5 **(a) The potential for logistical and technical problems in conducting an
6 election if the deadline for the registration of voters is changed;**

7 **(b) Any fiscal impact that would be likely to result from changing the
8 deadline for the registration of voters;**

9 **(c) The occurrence of voter fraud that would be likely to result from
10 changing the deadline for the registration of voters;**

11 **(d) The impact on voter turnout that would be likely to result from
12 changing the deadline for the registration of voters; and**

13 **(e) A review of the methods by which other states have provided for the
14 registration of voters on the date of the election.**

15 **3. On or before February 1, 2009, the Secretary of State and the county
16 clerks of each county jointly shall submit a written report of the results of the
17 study conducted pursuant to subsection 1 to the Director of the Legislative
18 Counsel Bureau for transmission to the 75th Session of the Nevada
19 Legislature.**

20 **Sec. 2. This act becomes effective on July 1, 2007.**
