AN ACT making appropriations to the State Department of Agriculture; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the State Department of Agriculture, Administration, the sum of ~~\$146,660~~
3 **\$138,725** for the purchase of servers for the Reno and Las Vegas offices and other
4 computer hardware and software, and the replacement of two vehicles.

5 2. There is hereby appropriated from the State General Fund to the State
6 Department of Agriculture for the Plant Industry Program the sum of \$267,045 for
7 the replacement of 14 vehicles.

8 3. There is hereby appropriated from the State General Fund to the State
9 Department of Agriculture, Veterinary Medical Services, the sum of ~~\$60,973~~
10 **\$51,973** for the purchase of new and replacement laboratory equipment for Reno
11 and Elko and to replace one veterinary vehicle.

12 **Sec. 2.** Any remaining balance of the appropriations made by section 1 of
13 this act must not be committed for expenditure after June 30, 2009, by the entity to
14 which the appropriation is made or any entity to which money from the
15 appropriation is granted or otherwise transferred in any manner, and any portion of
16 the appropriated money remaining must not be spent for any purpose after
17 September 18, 2009, by either the entity to which the money was appropriated or
18 the entity to which the money was subsequently granted or transferred, and must be
19 reverted to the State General Fund on or before September 18, 2009.

20 **Sec. 3.** This act becomes effective upon passage and approval.
