AN ACT making an appropriation to the Department of Transportation for highway improvements; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. There is hereby appropriated from the State General Fund to the
2 Department of Transportation **[the sum of \$170,000,000]** for improvements **, to**
3 **Interstate Highway 15 in Las Vegas]** funded by State General Fund revenues in
4 excess of the spending cap **[], to:**

- 5 1. **Interstate Highway 15 in Las Vegas, the sum of \$154,000,000.**
6 2. **State Route 160, Blue Diamond, from the junction with State Route**
7 **159 to Mountain Springs, the sum of \$16,000,000.**

8 Sec. 2. Any remaining balance of the **[appropriation] appropriations** made
9 by section 1 of this act must not be committed for expenditure after June 30, 2011,
10 by the entity to which the **[appropriation] appropriations are** made or any entity
11 to which money from **[the] an** appropriation is granted or otherwise transferred in
12 any manner, and any portion of the appropriated money remaining must not be
13 spent for any purpose after September 16, 2011, by either the entity to which the
14 money was appropriated or the entity to which the money was subsequently granted
15 or transferred, and must be reverted to the State General Fund on or before
16 September 16, 2011.

17 Sec. 3. This act becomes effective upon passage and approval.
