AN ACT relating to contractors; ~~[requiring the State Contractors’ Board to designate a contracting classification for licenses that authorize the licensee to abate or remove asbestos;]~~ requiring the **State Contractors’** Board to establish a specific limit on the amount of asbestos that a contractor not licensed to remove asbestos may remove; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law provides for contracting licenses to be classified as licenses for general
2 engineering contracting, general building contracting or specialty contracting. (NRS 624.215)
3 Existing law also authorizes the State Contractors’ Board to limit the field and scope of work
4 that may be done pursuant to a specific contracting license. (NRS 624.220) Existing law
5 authorizes a licensed specialty contractor to perform work outside the field and scope for
6 which the contractor is licensed if the work is incidental and supplemental to the performance
7 of work for which the contractor is licensed. (NRS 624.220)
8 ~~[This bill requires the Board to adopt regulations designating a specialty contracting~~
9 ~~classification for licenses that authorize the licensee to abate or remove asbestos.]~~ This bill
10 ~~[also]~~ requires the Board to adopt regulations establishing a specific limit on the amount of
11 asbestos that a contractor not licensed to remove asbestos may remove.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 624.220 is hereby amended to read as follows:
2 624.220 1. The Board shall adopt regulations necessary to effect the
3 classification and subclassification of contractors in a manner consistent with
4 established usage and procedure as found in the construction business, and may
5 limit the field and scope of the operations of a licensed contractor to those in which
6 he is classified and qualified to engage as defined by NRS 624.215 and the
7 regulations of the Board.

1 2. The Board shall limit the field and scope of the operations of a licensed
2 contractor by establishing a monetary limit on a contractor's license, and the limit
3 must be the maximum contract a licensed contractor may undertake on one or more
4 construction contracts on a single construction site or subdivision site for a single
5 client. The Board may take any other action designed to limit the field and scope of
6 the operations of a contractor as may be necessary to protect the health, safety and
7 general welfare of the public. The limit must be determined after consideration of
8 the factors set forth in NRS 624.260 to 624.265, inclusive.

9 3. A licensed contractor may request that the Board increase the monetary
10 limit on his license, either on a permanent basis or for a single construction project.
11 A request submitted to the Board pursuant to this subsection must be in writing on a
12 form prescribed by the Board and accompanied by such supporting documentation
13 as the Board may require. If a request submitted pursuant to this section is for a
14 single construction project, the request must be submitted to the Board at least 2
15 working days before the date on which the licensed contractor intends to submit his
16 bid for the project.

17 4. ~~Nothing~~ *Subject to the provisions of regulations adopted pursuant to*
18 *subsection 5, nothing* contained in this section prohibits a specialty contractor from
19 taking and executing a contract involving the use of two or more crafts or trades, if
20 the performance of the work in the crafts or trades, other than in which he is
21 licensed, is incidental and supplemental to the performance of work in the craft for
22 which the specialty contractor is licensed.

23 5. *The Board shall adopt regulations* ~~for~~
24 ~~(a) Designating a specialty contracting classification for licenses that~~

30 Sec. 2. This act becomes effective upon passage and approval.
