AN ACT making supplemental appropriations to the Department of Business and Industry; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State General Fund to
2 the Department of Business and Industry, Administration, the sum of **[\$65,844]**
3 **\$17,725** for **terminal leave costs,** Department of Information Technology charges
4 for PC/LAN tech and Silvernet services from Fiscal Year 2003-2004 . **[and for**
5 **relocation of the Office of the Director to Carson City.]** This appropriation is
6 supplemental to that made by section 23 of chapter 327, Statutes of Nevada 2003, at
7 page 1835, and section 24 of chapter 434, Statutes of Nevada 2005, at page 1941.

8 2. There is hereby appropriated from the State General Fund to the Consumer
9 Affairs Division of the Department of Business and Industry the sum of **[\$11,362]**
10 **\$2,869** for past expenditures . **[and terminal leave costs.]** This appropriation is
11 supplemental to that made by section 23 of chapter 327, Statutes of Nevada 2003, at
12 page 1835.

13 3. **[There is hereby appropriated from the State General Fund to the Division**
14 **of Insurance of the Department of Business and Industry the sum of \$20,000 for**
15 **damage to equipment and files that resulted from flooding. This appropriation is**
16 **supplemental to that made by section 24 of chapter 434, Statutes of Nevada 2005, at**
17 **page 1941.]**

18 4. There is hereby appropriated from the State General Fund to the Nevada
19 Athletic Commission of the Department of Business and Industry the sum of
20 \$9,446 for a shortfall that resulted from the retirement of the Executive Director.
21 This appropriation is supplemental to that made by section 24 of chapter 434,
22 Statutes of Nevada 2005, at page 1941.

23 **Sec. 2.** This act becomes effective upon passage and approval.
