AN ACT relating to public employees; including certain employees of the Department of Public Safety and certain park rangers and employees of the Division of State Parks of the State Department of Conservation and Natural Resources in the definition of “police officer” for various purposes relating to industrial injuries, occupational diseases and programs for public employees; making an appropriation; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law provides for certain police officers suffering from certain occupational diseases to receive disability benefits. (NRS 617.135, 617.455, 617.457, 617.485, 617.487) Existing law defines “police officer” for the purpose of providing those disability benefits to include various law enforcement officers in this State. (NRS 617.135) Existing law also grants the powers of peace officers to certain park rangers and employees of the Division of State Parks of the State Department of Conservation and Natural Resources. (NRS 289.260) **Section 1** of this bill expands the definition of police officer to make ~~those~~ certain employees of the Department of Public Safety and certain park rangers and division employees of the State Department of Conservation and Natural Resources eligible for the disability benefits provided to police officers. ~~for certain occupational diseases.~~ **Section 2** of this bill makes an appropriation to the Division for physical examinations for those park rangers and division employees.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1      **Section 1.** NRS 617.135 is hereby amended to read as follows:  
2      617.135 "Police officer" includes:  
3      1. A sheriff, deputy sheriff, officer of a metropolitan police department or city  
4      policeman;  
5      2. A chief, inspector, supervisor, commercial officer or trooper of the Nevada  
6      Highway Patrol Division of the Department of Public Safety;  
7      3. A chief, investigator or agent of the Investigation Division of the  
8      Department of Public Safety;  
9      4. A chief, supervisor, investigator or training officer of the Training  
Division of the Department of Public Safety;  
10     5. A chief or investigator of an office of the Department of Public Safety  
that conducts internal investigations of employees of the Department of Public  
Safety or investigates other issues relating to the professional responsibility of  
those employees;  
11     6. A chief or investigator of the Department of Public Safety whose duties  
include, without limitation:  
12        (a) The execution, administration or enforcement of the provisions of  
chapter 179A of NRS; and  
13        (b) The provision of technology support services to the Director and the  
divisions of the Department of Public Safety;  
14     7. An officer or investigator of the Section for the Control of Emissions From  
15      Vehicles and the Enforcement of Matters Related to the Use of Special Fuel of the  
16      Department of Motor Vehicles;  
17     8. An investigator of the Division of Compliance Enforcement of the  
18      Department of Motor Vehicles;  
19     9. A member of the police department of the Nevada System of Higher  
20      Education;  
21     10. A:  
22        (a) Uniformed employee of; or  
23        (b) Forensic specialist employed by,  
24      → the Department of Corrections whose position requires regular and frequent  
25      contact with the offenders imprisoned and subjects the employee to recall in  
26      emergencies;  
27     11. A parole and probation officer of the Division of Parole and  
28      Probation of the Department of Public Safety;  
29     12. A forensic specialist or correctional officer employed by the Division  
30      of Mental Health and Developmental Services of the Department of Health and  
31      Human Services at facilities for mentally disordered offenders;  
32     13. The State Fire Marshal, his assistant and his deputies; ~~and~~  
33     14. A game warden of the Department of Wildlife who has the powers  
34      of a peace officer pursuant to NRS 289.280 ~~;~~; and  
35     15. A ranger or employee of the Division of State Parks of the State  
Department of Conservation and Natural Resources who has the powers of a  
peace officer pursuant to NRS 289.260.  
36      **Sec. 2.** 1. There is hereby appropriated from the State General Fund to the  
37      Division of State Parks of the State Department of Conservation and Natural  
38      Resources, for the physical examinations required pursuant to NRS 617.454,  
39      617.455, 617.457, 617.485 and 617.487 for rangers or employees of the Division

5       2. Any balance of the sums appropriated by subsection 1 ~~must not be~~  
6 ~~committed for expenditure after June 30 of the respective fiscal years,~~ remaining  
7 at the end of the respective fiscal years by the entity to which the  
8 appropriation is made or any entity to which money from the appropriation is  
9 granted or otherwise transferred in any manner, and any portion of the  
10 appropriated money remaining must not be spent for any purpose after  
11 September 19, 2008, and September 18, 2009, respectively, by either the entity  
12 to which the money was appropriated or the entity to which the money was  
13 subsequently granted or transferred, and must be reverted to the State General  
14 Fund on or before September 19, 2008, and September 18, 2009, respectively.

15       **Sec. 3. 1. A person who, on July 1, 2007, is employed as a ranger or**  
16 **employee of the Division of State Parks of the State Department of**  
17 **Conservation and Natural Resources who has the powers of a peace officer**  
18 **pursuant to NRS 289.260 shall submit to a physical examination pursuant to**  
19 **NRS 617.454, 617.455 and 617.457 and a blood test to screen for Hepatitis C**  
20 **pursuant to NRS 617.487 on or after July 1, 2007, but on or before**  
21 **September 30, 2007. Each physical examination and blood test must be paid**  
22 **for by the Department.**

23       2. Notwithstanding the provisions of NRS 617.455, 617.457 and 617.487,  
24 if a person fails to submit to a physical examination or blood test required  
25 pursuant to subsection 1, the conclusive presumption relating to diseases of the  
26 lungs created by NRS 617.455, diseases of the heart created by NRS 617.457  
27 and infections of hepatitis C pursuant to NRS 617.487 shall be deemed, with  
28 regard to that person and for the purposes of those sections, to create a  
29 rebuttable presumption that the disease of the lungs or heart or infection of  
30 hepatitis C arose out of and in the course of the employment of the person as a  
31 ranger or employee specified in subsection 1.

32       **Sec. 4. This act becomes effective on July 1, 2007.**
