AN ACT relating to public employees; including certain employees of the Department of Public Safety and certain park rangers and employees of the Division of State Parks of the State Department of Conservation and Natural Resources in the definition of “police officer” for various purposes relating to industrial injuries, occupational diseases and programs for public employees; ~~revising certain provisions concerning heart disease as an occupational disease of volunteer firefighters;~~ making an appropriation; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law provides for certain police officers suffering from certain occupational diseases to receive disability benefits. (NRS 617.135, 617.455, 617.457, 617.485, 617.487) Existing law defines “police officer” for the purpose of providing those disability benefits to include various law enforcement officers in this State. (NRS 617.135) Existing law also grants the powers of peace officers to certain park rangers and employees of the Division of State Parks of the State Department of Conservation and Natural Resources. (NRS 289.260) **Section 1** of this bill expands the definition of police officer to make certain employees of the Department of Public Safety and certain park rangers and division employees of the State Department of Conservation and Natural Resources eligible for the disability benefits provided to police officers. **Section 2** of this bill makes an appropriation to the Division for physical examinations for those park rangers and division employees.

~~Existing law provides that, under certain circumstances, heart disease of a volunteer firefighter constitutes an occupational disease for purposes of chapter 617 of NRS. (NRS 617.457) Section 1.5 of this bill removes the requirement that the heart disease must have occurred before the volunteer firefighter reached 55 years of age. Section 1.5 also revises the frequency with which the volunteer firefighter must submit to a physical examination to detect such heart disease. Further, section 1.5 requires an applicant for employment as a volunteer firefighter to pay the cost of his initial physical examination and requires his employer to reimburse that cost if he is employed as a volunteer firefighter.]~~

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 617.135 is hereby amended to read as follows:

2 617.135 "Police officer" includes:

3 1. A sheriff, deputy sheriff, officer of a metropolitan police department or city
4 policeman;

5 2. A chief, inspector, supervisor, commercial officer or trooper of the Nevada
6 Highway Patrol Division of the Department of Public Safety;

7 3. A chief, investigator or agent of the Investigation Division of the
8 Department of Public Safety;

9 4. *A chief, supervisor, investigator or training officer of the Training
10 Division of the Department of Public Safety;*

11 5. *A chief or investigator of an office of the Department of Public Safety
12 that conducts internal investigations of employees of the Department of Public
13 Safety or investigates other issues relating to the professional responsibility of
14 those employees;*

15 6. *A chief or investigator of the Department of Public Safety whose duties
16 include, without limitation:*

17 (a) *The execution, administration or enforcement of the provisions of
18 chapter 179A of NRS; and*

19 (b) *The provision of technology support services to the Director and the
20 divisions of the Department of Public Safety;*

21 7. An officer or investigator of the Section for the Control of Emissions From
22 Vehicles and the Enforcement of Matters Related to the Use of Special Fuel of the
23 Department of Motor Vehicles;

45 **Sec. 1.5.** ~~NRS 617.457 is hereby amended to read as follows:~~

46 ~~617.457 1. Notwithstanding any other provision of this chapter, diseases of
47 the heart of a person who, for 5 years or more, has been employed in a full-time
48 continuous, uninterrupted and salaried occupation as a firefighter or police officer~~

1 in this State before the date of disablement are conclusively presumed to have
2 arisen out of and in the course of the employment.

3 ~~2. Notwithstanding any other provision of this chapter, diseases of the heart,
4 resulting in either temporary or permanent disability or death, are occupational
5 diseases and compensable as such under the provisions of this chapter if caused by
6 extreme overexertion in times of stress or danger and a causal relationship can be
7 shown by competent evidence that the disability or death arose out of and was
8 caused by the performance of duties as a volunteer firefighter by a person entitled
9 to the benefits of chapters 616A to 616D, inclusive, of NRS pursuant to the
10 provisions of NRS 616A.145 and who, for 5 years or more, has served continuously
11 as a volunteer firefighter in this State, [and who has not reached the age of 55 years
12 before the onset of the disease.]~~

13 ~~3. Except as otherwise provided in subsection 4, each employee who is to be
14 covered for diseases of the heart pursuant to the provisions of this section shall
15 submit to a physical examination, including an examination of the heart, upon
16 employment, upon commencement of coverage and thereafter on an annual basis
17 during his employment.~~

18 ~~4. A physical examination [is not required] for a volunteer firefighter [more
19 than] is required upon initial employment and once every 3 years after [an] the
20 initial examination [.] until the volunteer firefighter reaches the age of 50 years.
21 Each volunteer firefighter who is 50 years of age or older shall submit to a
22 physical examination once each year. The employer of the volunteer firefighter is
23 responsible for scheduling the physical examination.~~

24 ~~5. An applicant for the position as a volunteer firefighter who is 50 years of
25 age or older shall pay the cost of his initial physical examination described in
26 subsections 3 and 4. If the applicant is accepted for employment as a volunteer
27 firefighter, the employer of the volunteer firefighter shall reimburse him the cost
28 of the initial physical examination.~~

29 ~~6. [All] Except as otherwise provided in subsection 5, all physical
30 examinations required pursuant to [subsection] subsections 3 and 4 must be paid
31 for by the employer.~~

32 ~~[6.] 7. Failure to correct predisposing conditions which lead to heart disease
33 when so ordered in writing by the examining physician subsequent to the annual
34 examination excludes the employee from the benefits of this section if the
35 correction is within the ability of the employee.~~

36 ~~[7.] 8. A person who is determined to be:~~

37 ~~(a) Partially disabled from an occupational disease pursuant to the provisions
38 of this section; and~~

39 ~~(b) Incapable of performing, with or without remuneration, work as a
40 firefighter or police officer;~~

41 ~~may elect to receive the benefits provided under NRS 616C.440 for a permanent
42 total disability.~~

43 ~~[8.] 9. Claims filed under this section may be reopened at any time during the
44 life of the claimant for further examination and treatment of the claimant upon
45 certification by a physician of a change of circumstances related to the occupational
46 disease which would warrant an increase or rearrangement of compensation.]~~

48 **Sec. 2.** 1. There is hereby appropriated from the State General Fund to the
49 Division of State Parks of the State Department of Conservation and Natural
50 Resources, for the physical examinations required pursuant to NRS 617.454,
51 617.455, 617.457, 617.485 and 617.487 for rangers or employees of the Division
52 who are police officers pursuant to NRS 617.135 as amended by section 1 of this
53 act:

3	2. Any balance of the sums appropriated by subsection 1 remaining at the end	
4	of the respective fiscal years by the entity to which the appropriation is made or any	
5	entity to which money from the appropriation is granted or otherwise transferred in	
6	any manner, and any portion of the appropriated money remaining must not be	
7	spent for any purpose after September 19, 2008, and September 18, 2009,	
8	respectively, by either the entity to which the money was appropriated or the entity	
9	to which the money was subsequently granted or transferred, and must be reverted	
10	to the State General Fund on or before September 19, 2008, and September 18,	
11	2009, respectively.	
12	Sec. 3. 1. A person who, on July 1, 2007, is employed as a ranger or	
13	employee of the Division of State Parks of the State Department of Conservation	
14	and Natural Resources who has the powers of a peace officer pursuant to NRS	
15	289.260 shall submit to a physical examination pursuant to NRS 617.454, 617.455	
16	and 617.457 and a blood test to screen for hepatitis C pursuant to NRS 617.487 on	
17	or after July 1, 2007, but on or before September 30, 2007. Each physical	
18	examination and blood test must be paid for by the Department.	
19	2. Notwithstanding the provisions of NRS 617.455, 617.457 and 617.487, if a	
20	person fails to submit to a physical examination or blood test required pursuant to	
21	subsection 1, the conclusive presumption relating to diseases of the lungs created	
22	by NRS 617.455, diseases of the heart created by NRS 617.457 and infections of	
23	hepatitis C pursuant to NRS 617.487 shall be deemed, with regard to that person	
24	and for the purposes of those sections, to create a rebuttable presumption that the	
25	disease of the lungs or heart or infection of hepatitis C arose out of and in the	
26	course of the employment of the person as a ranger or employee specified in	
27	subsection 1.	
28	Sec. 4. This act becomes effective on July 1, 2007.
