AN ACT relating to crimes; prohibiting a person from engaging in certain acts to cause the results of a test for genetic identification which is given to determine paternity to be inaccurate; providing a penalty; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 This bill creates the crime of paternity fraud, making it a gross misdemeanor to engage in
2 certain acts which are intended to make the results of a test given for genetic identification to
3 determine the paternity of a child to be inaccurate.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 201 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 ***1. A person is guilty of paternity fraud if ~~he~~ the person:***

4 ***(a) Is ordered by a court to submit, or agrees to submit, to a test for genetic***
5 ***identification to determine the paternity of a child and knowingly assists, aids,***
6 ***abets, solicits or conspires with another person to have someone other than***
7 ***himself submit to the test for the purpose of preventing a determination that he is***
8 ***the father of the child; ~~for~~***

9 ***(b) Submits to a test for genetic identification to determine the paternity of a***
10 ***child in place of the person who has been ordered to submit, or who has agreed to***
11 ***submit, to a test for genetic identification to determine the paternity of a child for***
12 ***the purpose of preventing a determination that the person for whom he is taking***
13 ***the test is the father of the child ~~for~~; or***

14 ***(c) Knowingly assists, aids, abets, solicits or conspires with another person:***

- 1 (1) To commit a violation of paragraph (a) or (b); or
- 2 (2) To render inaccurate the results of a test for genetic identification to
- 3 determine the paternity of a child.
- 4 2. A person who violates this section is guilty of a gross misdemeanor.
