AN ACT relating to mortgage agents; authorizing a natural person to be licensed as a mortgage agent on behalf of a corporation or limited-liability company under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 This bill authorizes a natural person who is qualified to be licensed as a mortgage agent
2 under existing law to be issued such a license on behalf of a professional corporation of which
3 he is the sole shareholder or on behalf of a limited-liability company of which he is the
4 manager.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 645B of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 *1. Any natural person who meets the qualifications of a mortgage agent*
4 *and:*

5 *(a) Except as otherwise provided in subsection 2, is the sole shareholder of a*
6 *corporation organized pursuant to the provisions of chapter 89 of NRS; or*

7 *(b) Is the manager of a limited-liability company organized pursuant to the*
8 *provisions of chapter 86 of NRS,*

9 *↪ may be licensed on behalf of the corporation or limited-liability company for*
10 *the purpose of associating with a licensed mortgage broker in the capacity of a*
11 *mortgage agent.*

12 *2. The spouse of the owner of the corporation who has a community*
13 *interest in any shares of the corporation shall not be deemed a second*
14 *shareholder of the corporation for the purposes of paragraph (a) of subsection 1,*
15 *if the spouse does not vote any of those shares.*

16 *3. A license issued pursuant to this section entitles only the sole shareholder*
17 *of the corporation or the manager of the limited-liability company to act as a*

1 *mortgage agent, and only as an officer or agent of the corporation or limited-*
2 *liability company and not on his own behalf. The licensee shall not do or deal in*
3 *any act, acts or transactions included within the definition of a mortgage ~~agent~~*
4 *broker in NRS ~~[645B.0125,]~~ 645B.0127, except as that activity is permitted*
5 *pursuant to this chapter to licensed mortgage agents.*

6 4. *The corporation or limited-liability company shall, within 30 days after a*
7 *license is issued on its behalf pursuant to this section and within 30 days after*
8 *any change in its ownership, file an affidavit with the Division stating:*

9 (a) *For a corporation, the number of issued and outstanding shares of the*
10 *corporation and the names of all persons to whom the shares have been issued.*

11 (b) *For a limited-liability company, the names of members who have an*
12 *interest in the company.*

13 5. *A license issued pursuant to this section automatically expires upon:*

14 (a) *The death of the licensed shareholder in the corporation or the manager*
15 *of the limited-liability company; or*

16 (b) *The issuance of shares in the corporation to more than one person other*
17 *than the spouse.*

18 6. *This section does not alter any of the rights, duties or liabilities which*
19 *otherwise arise in the legal relationship between a mortgage broker or mortgage*
20 *agent and a person who deals with him.*

21 **Sec. 2.** ~~[NRS 645B.0122 is hereby amended to read as follows:~~

22 ~~—645B.0122—“Licensee” means a person who is licensed as a mortgage broker~~
23 ~~pursuant to this chapter. The term does not include a person issued a license as a~~
24 ~~mortgage agent pursuant to NRS 645B.410 [.] or section 1 of this act.] (Deleted by~~

26 **Sec. 3.** *This act becomes effective on July 1, 2007.*
