ASSEMBLY JOINT RESOLUTION—Urging the Secretary of the Interior to fully fund the interagency airtanker base programs for wildland fire suppression in **Battle Mountain**, Minden and Stead.

1 WHEREAS, The United States Department of the Interior, through the Bureau of
2 Land Management, has provided vital fire suppression services to the State of
3 Nevada; and

4 WHEREAS, These services include air support for wildland fire suppression in
5 northern Nevada through interagency airtanker base operations at the **Battle**
6 **Mountain**, Minden-Tahoe and Reno Stead Airports; and

7 WHEREAS, The areas of service include the forests and watershed surrounding
8 Lake Tahoe, one of the nation's premiere natural treasures, and the wildland urban
9 interface along the Sierra Front in both Nevada and California; and

10 WHEREAS, In July 2006, Nevada ranked first in the nation in the amount of
11 wildland acreage burned by wildfire in the United States; and

12 WHEREAS, The Federal Government owns and manages 87 percent of the land
13 in Nevada; and

14 WHEREAS, The Bureau of Land Management has provided exemplary air
15 support for fighting the wildland fires which have threatened Nevada's residents,
16 private property, public lands and other valuable natural resources; and

17 WHEREAS, The Sierra Front has complex and challenging conditions that
18 generate volatile and high-intensity wildland fires which are fought over rugged
19 terrain, and airtankers are a critical component of the fight, being used primarily for
20 initial attack and support; and

21 WHEREAS, Continued funding for the full operation of the interagency airtanker
22 base programs in **Battle Mountain**, Minden and Stead with single-engine

1 airtankers that can provide the quick response needed for early suppression of a
2 wildland fire is critical; and

3 WHEREAS, The Secretary of the Interior has the authority to authorize the
4 expenditure of money to provide full funding for the interagency airtanker base
5 programs; now, therefore, be it

6 RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY,
7 That the members of the 74th Session of the Nevada Legislature hereby urge the
8 Secretary of the Interior to fully fund the interagency airtanker base programs for
9 wildland fire suppression in **Battle Mountain**, Minden and Stead; and be it further

10 RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy
11 of this resolution to the Vice President of the United States as the presiding officer
12 of the United States Senate, the Speaker of the House of Representatives, the
13 Secretary of the Interior and each member of the Nevada Congressional Delegation;
14 and be it further

15 RESOLVED, That this resolution becomes effective upon passage.
