ASSEMBLY JOINT RESOLUTION—Urging Congress to allow certain proceeds from the Southern Nevada Public Land Management Act **of 1998** to be used for Nevada's state parks.

1        WHEREAS, In 1998, Congress passed the Southern Nevada Public Land  
2 Management Act ***of 1998***, Public Law 105-263, which allows the **Bureau of**  
3 ***Land Management*** ***Secretary of the Interior*** to sell certain federal lands in Clark  
4 County, Nevada, for possible development and authorizes use of the proceeds to  
5 acquire, conserve and protect environmentally sensitive lands in the State of  
6 Nevada; and

7        WHEREAS, Under the provisions of the Act, 5 percent of the profits from sales  
8 of the land is allocated to help fund education, 10 percent is allocated for water and  
9 airport infrastructure projects and the remaining 85 percent is deposited into a  
10 special account for disbursement; and

11      WHEREAS, The money in the special account is specified for certain capital  
12 improvement projects, including projects at Lake Mead, Red Rock Canyon, the  
13 Desert National Wildlife Refuge and other federally managed recreational areas,  
14 the development of parks, trails and a multispecies habitat conservation plan in and  
15 around Clark County, the acquisition of environmentally sensitive lands, and  
16 restoration and conservation of the Lake Tahoe Basin; and

17      WHEREAS, Since the first auction of land in 1999, this Act has generated  
18 approximately \$3 billion, \$2.5 billion of which has been disbursed from the special  
19 account; and

20      WHEREAS, Although the money distributed pursuant to the Act has been used  
21 for the enhancement and conservation of many federally managed areas in Nevada,  
22 there are numerous state parks in Nevada which could also benefit from this money  
23 ; ***including Valley of Fire, Cathedral Gorge, Spring Mountain Ranch, Dayton,***  
24 ***Berlin Ichthyosaur and Rye Patch;*** and

25      WHEREAS, With the growing popularity of the many rural recreational and  
26 historic sites in Nevada, it is vital that ***[these lands]*** ***Nevada's state parks*** be

1 maintained and preserved for the continued enjoyment of the residents of Nevada  
2 and its tourists; now, therefore, be it

3 RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF NEVADA, JOINTLY,  
4 That the members of the Nevada Legislature urge Congress to amend the Southern  
5 Nevada Public Land Management Act **of 1998** to authorize the State of Nevada to  
6 use a portion of the money in the special account for the improvement and  
7 preservation of Nevada's state parks; and be it further

8 RESOLVED, That the Chief Clerk of the Assembly prepare and transmit a copy  
9 of this resolution to the Vice President of the United States as the presiding officer  
10 of the United States Senate, the Speaker of the House of Representatives, the  
11 Secretary of the Interior and each member of the Nevada Congressional Delegation;  
12 and be it further

13 RESOLVED, That this resolution becomes effective upon passage.
