AN ACT relating to state financial administration; providing for the payment of a bonus to certain members of the Nevada National Guard or the Reserves who are called to active duty in the Armed Forces of the United States after September 11, 2001, to serve in military expeditions or operations to combat terrorism; establishing the criteria for calculating the amount of the bonus; **authorizing allocations to pay for the bonuses;** and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 ~~This~~ **Section 1 of this** bill provides for the payment of a bonus to certain members of
2 the Nevada National Guard or the Reserves who are called to active duty in the Armed Forces
3 of the United States after September 11, 2001, to serve in military expeditions or operations to
4 combat terrorism. ~~This bill~~ **Section 1** also establishes the criteria for calculating the amount
5 of the bonus to be awarded. **Section 2 of this bill authorizes allocations for paying the**
6 **bonuses.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 412 of NRS is hereby amended by adding thereto a new
2 section to read as follows:

3 1. *A member of the Reserves who is a resident of this State or a member of*
4 *the Nevada National Guard who:*

5 (a) *Enters and serves in the active military service of the United States after*
6 *September 11, 2001, in military expeditions or operations to combat terrorism;*
7 *and*

8 (b) *Receives, upon severance from such service, an honorable discharge or*
9 *certificate of satisfactory service from the Armed Forces of the United States or*
10 *resumes his status as a member in good standing in the Nevada National Guard,*
11 *or who, having so served, is still serving in the Armed Forces of the United States,*
12 *is entitled to a bonus from this State in an amount determined pursuant to*
13 *subsection 2.*

14 2. *The amount of the bonus provided for in subsection 1.:* ~~*is:*~~

15 (a) ~~*Five hundred dollars*~~ *Is \$175* for each month, or part thereof, after
16 *September 11, 2001, of service in military expeditions to combat terrorism; and*

17 (b) ~~*Two hundred fifty dollars*~~ *Is \$75* for each month, or part thereof, after
18 *September 11, 2001, of service in military operations to combat terrorism,*
19 *but in no case may the amount of the bonus be greater than* ~~*\$10,000*~~ *\$5,000*
20 *for the time during which such a bonus may be paid.*

21 3. *The Adjutant General shall adopt regulations to carry out the provisions*
22 *of this section.*

23 4. *As used in this section:*

24 (a) *“Global War on Terrorism Expeditionary Medal” and “Global War on*
25 *Terrorism Service Medal” mean the medals established pursuant to Executive*
26 *Order 13289, 68 F.R. 12567.*

27 (b) *“Military expeditions to combat terrorism” means military expeditions for*
28 *which the Global War on Terrorism Expeditionary Medal is authorized.*

29 (c) *“Military operations to combat terrorism” means military operations for*
30 *which the Global War on Terrorism Service Medal is authorized.*

31 (d) *“Reserves” means the Air Force Reserve, Army Reserve, Coast Guard*
32 *Reserve, Marine Reserve and Naval Reserve.*

33 **Sec. 2. Section 1 of Assembly Bill No. 617 of this session is hereby**
34 **amended to read as follows:**

35 Section 3. 1. There is hereby appropriated from the State General
36 Fund to the Interim Finance Committee the sum of \$36,000,000.

37 2. If the State Board of Examiners finds that circumstances for which
38 the Legislature has made no other provision require a substantial
39 expenditure that greatly exceeds the amount appropriated by the Legislature
40 for that purpose, it may request an allocation by the Interim Finance
41 Committee from the amount appropriated pursuant to subsection 1. If the
42 Interim Finance Committee determines that the expenditure is required, that
43 the amount greatly exceeds the amount appropriated by the Legislature for
44 that purpose and that no other source of funding is available for the
45 expenditure, the Interim Finance Committee may approve an allocation
46 from the appropriation. The Interim Finance Committee shall by resolution
47 establish the amount and purpose of the allocation, and direct the State
48 Controller to transfer that amount to the appropriate fund and account. The
49 State Controller shall thereupon make the transfer. The Interim Finance

1 Committee is not bound to follow the recommendation of the State Board
2 of Examiners.

3 **3. Upon request of the Office of the Military, the Interim Finance**
4 **Committee may allocate money from the amount appropriated**
5 **pursuant to subsection 1 for distribution to the Office of the Military to**
6 **pay the bonuses provided for in section 1 of this act. The Interim**
7 **Finance Committee shall by resolution establish the amount of the**
8 **allocation and direct the State Controller to transfer that amount to the**
9 **appropriate fund and account. The State Controller shall thereupon**
10 **make the transfer.**

11 **4.** Upon receipt of the projections and estimates of the Economic
12 Forum pursuant to paragraph (d) of subsection 1 of NRS 353.228 that are
13 required to be reported before December 1, 2008, the Interim Finance
14 Committee shall project the ending balance in the State General Fund for
15 the Fiscal Year 2008-2009, using all relevant information available. If the
16 projected ending fund balance for the Fiscal Year 2008-2009 exceeds the
17 amount estimated by the 2007 Legislature, any remaining balance of the
18 amount appropriated pursuant to subsection 1 must be transferred on
19 January 1, 2009, to the Fund to Stabilize the Operation of State
20 Government created pursuant to NRS 353.288.

23 **2. Section 1 of this act** expires by limitation on June 30, 2009.
