AN ACT relating to the Reno-Tahoe Airport Authority; exempting certain contracts entered into by the Board of Trustees of the Authority from certain requirements; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Under existing law, the Reno-Tahoe Airport Authority is subject, with certain exceptions, to the Local Government Purchasing Act and requirements relating to competitive bidding on public works. (Chapters 332, 338 and 339 of NRS; Reno-Tahoe Airport Authority Act §§ 9, 9.5, 10.2) This bill exempts the Authority from the Local Government Purchasing Act and certain requirements relating to contracts for public works **[for contracts entered into by the Board of Trustees of the Authority for a project concerning which the relevant information has been determined]** **for the construction or installation of an integrated in-line explosive detection system that is mandated** by the Transportation Security Administration of the United States Department of Homeland Security. **[to constitute sensitive security information pursuant to 49 C.F.R. Part 1520.]** **This bill also provides that such exemption expires by limitation on July 1, 2009.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** The Reno-Tahoe Airport Authority Act, being chapter 474,
2 Statutes of Nevada 1977, at page 968, is hereby amended by adding thereto a new
3 section to be designated as section 9.3, immediately following section 9, to read as
4 follows:

5 *Sec. 9.3. 1. Except as otherwise provided in subsection 2, the
6 provisions of any law requiring public bidding or otherwise imposing
7 requirements on any public contract, project, acquisition, works or
8 improvements, including, without limitation, the provisions of chapters
9 332, 338 and 339 of NRS, do not apply to any contract entered into by the
10 Board for [a project, acquisition, works or improvement concerning
11 which the relevant information has been determined] the construction or
12 installation of an integrated in-line explosive detection system mandated
13 by the Transportation Security Administration of the United States
14 Department of Homeland Security. [to constitute sensitive security
15 information pursuant to 49 C.F.R. Part 1520.]*

16 *2. A contract entered into by the Board pursuant to this section
17 must contain a provision stating that the requirements of NRS 338.010 to
18 338.090, inclusive, apply to any construction work performed pursuant to
19 the contract.*

20 3. As used in this section:

21 (a) "Explosive detection system" means a system described in 49
22 U.S.C. § 44901(d).

23 (b) "Integrated in-line explosive detection system" means an
24 explosive detection system that is integrated into an airport's baggage
25 handling conveyor system.

26 **Sec. 2.** Section 9 of the Reno-Tahoe Airport Authority Act, being chapter
27 474, Statutes of Nevada 1977, as last amended by chapter 369, Statutes of Nevada
28 2005, at page 1391, is hereby amended to read as follows:

29 Sec. 9. 1. Except as otherwise provided in subsection 2 and
30 ~~[section]~~ sections 9.3 and 9.5 of this act, the Board shall comply with the
31 provisions of the Local Government Purchasing Act and the Local
32 Government Budget and Finance Act.

33 2. Except as otherwise provided in section 10.2 of this act, any
34 concession agreement entered into by the Authority in conformity with the
35 provisions of that section need not conform to the requirements of the Local
36 Government Purchasing Act.

37 **Sec. 3.** This act becomes effective upon passage and approval ~~¶~~ and expires
38 by limitation on July 1, 2009.
