SUMMARY—Revises provisions relating to the Program to Encourage and Facilitate Purchases by Agencies of Commodities and Services From Organizations. (BDR 27-609)

AN ACT relating to purchasing; requiring organizations that wish to participate in the Program to Encourage and Facilitate Purchases by Agencies of Commodities and Services From Organizations to register with and submit quarterly reports to the Rehabilitation Division of the Department of Employment, Training and Rehabilitation; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law requires the Rehabilitation Division of the Department of Employment, Training and Rehabilitation to establish a Program to Encourage and Facilitate Purchases by Agencies of Commodities and Services From Organizations. (NRS 334.025) Existing law also authorizes an exception to the competitive bidding process for purchasing by the State and by local governments from organizations and agencies whose primary purpose is the training and employment of persons with mental or physical disabilities. (NRS 332.117, 333.375) **Sections 1-3** of this bill require organizations that wish to participate in the Program and qualify for the exemption to the competitive bidding process to register with, and to submit quarterly reports to, the Rehabilitation Division.

Section 4 of this bill requires the Administrator of the Division to review the registration and reporting requirements imposed by this bill and to report on that review to the 75th Session of the Nevada Legislature.

Section 5 of this bill repeals the expiration of section 14 of chapter 377, Statutes of Nevada 2005, at page 1445. Thus, the changes made by section 14 of that chapter of Statutes of Nevada to NRS 334.025 will no longer expire by limitation on June 30, 2013, and the Program will continue to be administered by the Division instead of a Committee on Employment of Persons with Disabilities created by the Governor.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 332.117 is hereby amended to read as follows:

2 332.117 1. ~~[A]~~ *In accordance with the Program to Encourage and*
3 *Facilitate Purchases by Agencies of Commodities and Services From*
4 *Organizations established pursuant to NRS 334.025, a* governing body of a local
5 government or its authorized representative may award, without complying with the
6 requirements for competitive bidding set forth in this chapter, a contract for
7 services or for the purchase of supplies, materials, equipment or labor to an
8 organization or agency whose primary purpose is the training and employment of
9 persons with a mental or physical disability, including, without limitation, a
10 community-based training center for the care and training of mentally and
11 functionally retarded persons described in chapter 435 of NRS.

12 2. An organization or agency that ~~[wishes]~~ :

13 (a) *Wishes* to submit a bid for such a contract must ~~[establish]~~ :

14 (1) *Register with the Rehabilitation Division of the Department of*
15 *Employment, Training and Rehabilitation as required pursuant to NRS 334.025;*
16 *and*

17 (2) *Establish* a fair-market price for those services, supplies, materials,
18 equipment or labor by conducting a market survey and must include the survey
19 with the bid submitted to the local government.

20 (b) *Is awarded such a contract must report quarterly to the Rehabilitation*
21 *Division as required pursuant to NRS 334.025.*

22 **Sec. 2.** NRS 333.375 is hereby amended to read as follows:

23 333.375 1. The provisions of NRS 331.100 notwithstanding, *and in*
24 *accordance with the Program to Encourage and Facilitate Purchases by*
25 *Agencies of Commodities and Services From Organizations established pursuant*
26 *to NRS 334.025, the Purchasing Division may award without accepting competitive*
27 bids a contract for services or the purchase of commodities to organizations or
28 agencies whose primary purpose is the training and employment of persons with a
29 mental or physical disability, including, without limitation, a community-based
30 training center for the care and training of mentally and functionally retarded
31 persons described in chapter 435 of NRS.

32 2. An organization or agency that ~~[wishes]~~ :

33 (a) *Wishes* to submit a bid for such a contract must ~~[establish]~~ :

34 (1) *Register with the Rehabilitation Division of the Department of*
35 *Employment, Training and Rehabilitation as required pursuant to NRS 334.025;*

37 (2) *Establish* a fair-market price for those services or commodities by
38 conducting a market survey and must include the survey with the bid submitted to
39 the Purchasing Division.

40 (b) *Is awarded such a contract must report quarterly to the Rehabilitation*
41 *Division as required pursuant to NRS 334.025.*

42 **Sec. 3.** NRS 334.025 is hereby amended to read as follows:

43 334.025 1. The Rehabilitation Division of the Department of Employment,
44 Training and Rehabilitation shall establish and administer a Program to Encourage
45 and Facilitate Purchases by Agencies of Commodities and Services From
46 Organizations.

47 2. The Program may include:

1 (a) A method for assisting an agency that wishes to purchase commodities or
2 services from an organization to locate such commodities and services that meet the
3 needs of the agency;

4 (b) A method for assisting an organization to locate an agency that wishes to
5 purchase commodities or services from organizations;

6 (c) A method for encouraging agencies to purchase commodities and services
7 from organizations;

8 (d) A method to review objections to an award of a contract to an organization,
9 which method must be limited to a review of the process used for awarding the
10 contract to ensure that the appropriate procedures were followed in awarding the
11 contract;

12 (e) The establishment of a percentage, not to exceed 4 percent, of the full
13 amount of payment to an organization which is awarded a contract for all
14 commodities and services to be provided to the agency pursuant to the contract that
15 is sufficient to pay the cost to the Rehabilitation Division of establishing and
16 administering the Program; and

17 (f) A method for collecting information from an agency in a report to the
18 Rehabilitation Division, which report may include, without limitation:

19 (1) The number of persons currently employed at the agency who are
20 mentally or physically disabled; and

21 (2) The number of contracts the agency has entered into pursuant to the
22 Program which are currently in effect and a list of the organizations with which the
23 agency has entered such contracts.

24 3. *An organization that wishes to participate in the Program must register*
25 *with the Rehabilitation Division on a form prescribed by the Administrator before*
26 *contacting any agency concerning entering into a contract pursuant to the*
27 *Program.*

28 4. In administering the Program, the Rehabilitation Division shall, upon
29 request of an agency or organization, assist the agency or organization in
30 establishing a contract for the purchase of commodities or services.

31 ~~4.~~ 5. A contract entered into pursuant to the Program must provide for a
32 payment to the Rehabilitation Division in an amount equal to the full amount of
33 payment to the organization for all commodities and services to be provided to the
34 agency pursuant to the contract multiplied by the percentage established pursuant to
35 paragraph (e) of subsection 2.

36 ~~5.~~ 6. *An organization that has entered into a contract with an agency*
37 *pursuant to the Program shall report quarterly to the Rehabilitation Division, on*
38 *a form prescribed by the Administrator, such information as the Rehabilitation*
39 *Division deems necessary to administer the Program.*

40 7. *The Administrator may adopt regulations to carry out the provisions of*
41 *this section.*

42 8. As used in this section:

43 (a) *“Administrator” means the Administrator of the Rehabilitation Division*
44 *of the Department of Employment, Training and Rehabilitation.*

45 (b) *“Agency” means a local government as defined in NRS 332.015 and using*
46 *agencies as defined in NRS 333.020.*

47 ~~(b)~~ (c) *“Organization” means an organization whose primary purpose is the*
48 *training and employment of mentally or physically disabled persons, including,*
49 *without limitation, community-based training centers for the care and training of*
50 *mentally and functionally retarded persons described in chapter 435 of NRS.*

51 **Sec. 4. 1. The Administrator of the Rehabilitation Division of the**
52 **Department of Employment, Training and Rehabilitation shall review the**

1 registration and reporting requirements imposed by the amendatory
2 provisions of this act.

3 2. The Administrator shall prepare a report summarizing the review and
4 submit the report by July 1, 2008, to the Director of the Legislative Counsel
5 Bureau for transmittal to the Legislative Commission and to the 75th Session
6 of the Nevada Legislature. The report must be made available to the general
7 public.

8 ~~Sec. 4.~~ Sec. 5. Section 18 of Chapter 377, Statutes of Nevada 2005, at
9 page 1445, is hereby amended to read as follows:

10 Sec. 18. 1. This section and sections 1 to ~~14.~~ 13, inclusive, and 17
11 of this act become effective upon passage and approval and expire by
12 limitation on June 30, 2013.

13 2. *Section 14 of this act becomes effective upon passage and*
14 *approval.*

15 3. Section 16 of this act becomes effective on July 1, 2005.

17 expires by limitation on June 30, 2013.
