AN ACT relating to health; creating ~~the Nevada Academy of Health; prescribing its powers and duties; creating the governing body of the Academy; prescribing its powers and duties;~~ **an advisory committee to the Legislative Committee on Health Care;** and providing other matters properly relating thereto.

1 ~~Section 6 of this bill creates the Nevada Academy of Health. Section 7 of this bill~~

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Delete existing sections 1 through 13 of this bill and replace with the following
2 new sections 1 and 2:

3 **Section 1.** Chapter 439B of NRS is hereby amended by adding thereto a
4 new section to read as follows:

5 1. There is hereby established an advisory committee to the Committee
6 consisting of 14 members as follows:

7 (a) The Director or his designee;

8 (b) One member who represents the Nevada System of Higher Education
9 appointed by the Board of Regents of the University of Nevada;

10 (c) Six members appointed by the Governor;

11 (d) Two members appointed by the Majority Leader of the Senate;

12 (e) Two members appointed by the Speaker of the Assembly;

13 (f) One member appointed by the Minority Leader of the Senate; and

14 (g) One member appointed by the Minority Leader of the Assembly.

15 2. The Chairman of the advisory committee must be elected from among the
16 members of the advisory committee.

17 3. Each member of the advisory committee who is not an officer or
18 employee of the State serves without compensation and is not entitled to receive a
19 per diem allowance or travel expenses.

20 4. Each member of the advisory committee who is an officer or employee of
21 the State must be relieved from his duties without loss of his regular
22 compensation so that he may attend meetings of the Committee or the advisory
23 committee and is entitled to receive the per diem allowance and travel expenses
24 provided for state officers and employees generally, which must be paid by the
25 state agency that employs him.

26 **Sec. 2.** This act becomes effective on July 1, 2007, and expires by
27 limitation on June 30, 2009.
