AN ACT making a supplemental appropriation to the Department of Education, other state education programs, to fund the Counselor National Board Certification Program **and teacher signing bonuses**; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General Fund to the
2 Department of Education, other state education programs : [**the**]

3 **1. The** sum of \$125,000 to fund projected expenditures for the Counselor
4 National Board Certification Program through the end of Fiscal Year 2007. This
5 appropriation is supplemental to that made by section 15 of chapter 434, Statutes of
6 Nevada 2005, at page 1938.

7 **2. The sum of \$1,496,000 to fund projected expenditures for teacher
8 signing bonuses through the end of Fiscal Year 2007. This appropriation is
9 supplemental to that made by section 15 of chapter 434, Statutes of Nevada
10 2005, at page 1938.**

11 **Sec. 2.** This act becomes effective upon passage and approval.
