SUMMARY—Amends the Charter of the City of North Las Vegas concerning the qualifications of municipal judges ~~to~~ **prospectively contingent upon voter approval.** (BDR S-80)

AN ACT relating to judges; **prospectively** amending the Charter of the City of North Las Vegas concerning the qualifications of municipal judges ~~to~~ **contingent upon voter approval**; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 ~~This~~ **Section 1 of this** bill amends the Charter of the City of North Las Vegas to require
2 a municipal judge to devote his full time to the duties of his office and to be a duly licensed
3 member, in good standing, of the State Bar of Nevada. This requirement does not apply to a
4 municipal judge who holds the office of municipal judge on ~~October 1, 2007,~~ **January 1,**
5 **2009,** and who continues to serve as such in uninterrupted terms. **The provisions of section 1**
6 **will become effective on January 1, 2009, only if the voters of the City of North Las**
7 **Vegas approve of the effect of those provisions at the 2008 General Election.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 4.020 of the Charter of the City of North Las Vegas, being
2 Chapter 573, Statutes of Nevada 1971, as last amended by Chapter 73, Statutes of
3 Nevada 2003, at page 485, is hereby amended to read as follows:

4 Sec. 4.020 Municipal Court: ~~Residency requirement~~ *Qualifications*
5 of Municipal Judge; salary.

6 1. A Municipal Judge must have been a resident of the City for a
7 continuous period of at least 6 months immediately preceding his election.

8 2. *A Municipal Judge shall devote his full time to the duties of his*
9 *office and must be a duly licensed member, in good standing, of the State*
10 *Bar of Nevada, except that the requirement to be a duly licensed member,*
11 *in good standing, of the State Bar of Nevada does not apply to any*
12 *Municipal Judge who holds the office of Municipal Judge on*

1 ~~October 1, 2007,~~ January 1, 2009, as long as he continues to serve as
2 such in uninterrupted terms.

3 3. If so required by an ordinance duly enacted, candidates for the
4 office of Municipal Judge, at the time of filing, shall produce evidence in
5 satisfaction of any or all of the qualifications for office.

6 ~~3.~~ 4. The salary of a Municipal Judge must be fixed by the City
7 Council, must be uniform for all departments of the Municipal Court and
8 may be increased during the term for which a Municipal Judge is elected or
9 appointed.

10 **Sec. 2. At the general election on November 4, 2008, in the City of North**
11 **Las Vegas, a question must be placed on the general election ballot in**
12 **substantially the following form:**

13 **Shall Section 4.020 of the Charter of the City of North Las Vegas**
14 **be amended to require a Municipal Judge who holds the office of**
15 **Municipal Judge after January 1, 2009:**

16 1. To devote his full time to the duties of his office; and

17 2. Except for a Municipal Judge who holds the office of Municipal
18 Judge on January 1, 2009, and continues to serve in uninterrupted
19 terms, to be a duly licensed member, in good standing, of the State Bar
20 of Nevada?

21 **Sec. 3. 1. This section and section 2 of this act become effective on**
22 **October 1, 2007.**

23 2. Section 1 of this act becomes effective on January 1, 2009, only if a
24 majority of the voters voting on the question placed on the ballot pursuant to
25 section 2 of this act vote affirmatively on the question.
