SUMMARY—Prohibits a person from allowing a cat or dog to remain unattended in a motor vehicle under certain circumstances. (BDR 50-950)

AN ACT relating to animals; prohibiting a person from allowing a cat or dog to remain unattended in a parked or standing motor vehicle in a manner that endangers the health or safety of the cat or dog; authorizing a peace officer to use force to remove a cat or dog from a motor vehicle under certain circumstances; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

Under existing law, a person is prohibited from instigating, engaging in or in any way furthering an act of cruelty to an animal. (NRS 574.100) Such an act includes, without limitation, unjustifiably injuring or maiming an animal or carrying an animal in a vehicle in a cruel or inhuman manner. (NRS 574.100, 574.190)

**Section 2** of this bill makes it a misdemeanor for a person to allow a cat or dog to remain unattended in a parked or standing car during a period of extreme heat or cold or in any other manner that endangers the health or safety of the cat or dog. **Section 2** authorizes a peace officer and certain other persons to use any force that is reasonable and necessary under the circumstances to remove the cat or dog from the motor vehicle. **Section 5** of this bill provides that the existing general exemptions from the provisions of chapter 574 of NRS also apply to the activities specified in **section 2** of this bill. Those exemptions include, without limitation, the handling, housing and transporting of livestock or farm animals.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** (Deleted by amendment.)

**Sec. 2.** Chapter 574 of NRS is hereby amended by adding thereto a new section to read as follows:

*1. Except as otherwise provided in subsection 3, a person shall not allow a cat or dog to remain unattended in a parked or standing motor vehicle during a*

1 *period of extreme heat or cold or in any other manner that endangers the health*  
 2 *or safety of the cat or dog.*

3 2. Any:

4 (a) Peace officer;

5 (b) Officer of a society for the prevention of cruelty to animals who is  
 6 authorized to make arrests pursuant to NRS 574.040;

7 (c) Animal control officer;

8 (d) Governmental officer or employee whose primary duty is to ensure public  
 9 safety;

10 (e) Employee or volunteer of any organized fire department; or

11 (f) Member of a search and rescue organization in this State that is under  
 12 the direct supervision of a sheriff,

13 *↳ may use any force that is reasonable and necessary under the circumstances to*  
 14 *remove from a motor vehicle a cat or dog that is allowed to remain in the motor*  
 15 *vehicle in violation of subsection 1.*

16 3. The provisions of subsection 1 do not apply to:

17 (a) A police animal or an animal that is used by :

18 (1) A federal law enforcement agency to assist the agency in carrying out  
 19 the duties of the agency; or

20 (2) A search and rescue organization specified in paragraph (f) of  
 21 subsection 2 to assist the organization in carrying out the activities of the  
 22 organization; or

23 (b) A dog that is under the possession or control of:

24 (1) An animal control officer; or

25 (2) A first responder during an emergency. ~~† or~~

26 ~~— (c) A dog that is transported or used for hunting a species of game mammal;~~

27 ~~— (1) During the season for hunting that species of game mammal; and~~

28 ~~— (2) By a person who is the holder of a license or tag to hunt that species~~  
 29 ~~of game mammal during that season.]~~

30 4. A cat or dog that is removed from a motor vehicle pursuant to subsection  
 31 2 shall be deemed to be an animal being treated cruelly for the purposes of NRS  
 32 574.055. The person who removed the cat or dog may take any action relating to  
 33 the cat or dog specified in that section and is entitled to any lien or immunity  
 34 from liability that is applicable pursuant to that section.

35 5. A person who violates a provision of subsection 1 is guilty of a  
 36 misdemeanor.

37 **Sec. 3.** (Deleted by amendment.)

38 **Sec. 4.** NRS 574.050 is hereby amended to read as follows:

39 574.050 As used in NRS 574.050 to 574.200, inclusive ~~†~~, *and section 2 of*  
 40 *this act:*

41 1. “Animal” does not include the human race, but includes every other living  
 42 creature.

43 2. “First responder” means a person who has successfully completed the  
 44 national standard course for first responders.

45 3. “Police animal” means an animal which is owned or used by a state or local  
 46 governmental agency and which is used by a peace officer in performing his duties  
 47 as a peace officer.

48 ~~†~~ 4. “Torture” or “cruelty” includes every act, omission or neglect, whereby  
 49 unjustifiable physical pain, suffering or death is caused or permitted.

50 **Sec. 5.** NRS 574.200 is hereby amended to read as follows:

51 574.200 The provisions of NRS 574.050 to 574.510, inclusive, *and section 2*  
 52 *of this act* do not:

- 1           1. Interfere with any of the fish and game laws contained in title 45 of NRS or  
2 any laws for the destruction of certain birds.
- 3           2. Interfere with the right to destroy any venomous reptiles or animals, or any  
4 animal known as dangerous to life, limb or property.
- 5           3. Interfere with the right to kill all animals and fowl used for food.
- 6           4. Prohibit or interfere with any properly conducted scientific experiments or  
7 investigations which are performed under the authority of the faculty of some  
8 regularly incorporated medical college or university of this State.
- 9           5. Interfere with any scientific or physiological experiments conducted or  
10 prosecuted for the advancement of science or medicine.
- 11          6. Prohibit or interfere with established methods of animal husbandry,  
12 including the raising, handling, feeding, housing and transporting of livestock or  
13 farm animals.
