AN ACT making supplemental appropriations to the State Department of Conservation and Natural Resources to fund fire suppression and to pay utility costs; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General Fund to the:

2 1. ~~Division of State Parks of the State Department of Conservation and
3 Natural Resources the sum of \$37,805 for unanticipated utility costs for Fiscal Year
4 2006-2007.~~

5 2. ~~State Department of Conservation and Natural Resources, Forest Fire
6 Suppression/Emergency Response, Division of Forestry of the State Department
7 of Conservation and Natural Resources for Fire Suppression/Emergency
8 Response the sum of ~~\$1,661,801~~ \$1,660,873 for forest fire suppression costs that
9 were not funded from the Disaster Relief Account created by NRS 353.2735.~~

10 **Sec. 2.** Division of Forestry of the State Department of Conservation and
11 Natural Resources the sum of ~~\$17,983~~ \$69,643 for a projected shortfall for utility
12 costs and incorrectly budgeted aircraft insurance.

13 **Sec. 2.** The appropriations made in section 1 of this act are supplemental to
14 those made by section 26 of chapter 434, Statutes of Nevada 2005, at page 1942.

15 **Sec. 3.** This act becomes effective upon passage and approval.
